

# Alinea "Fund & Win up to \$1,000" Promotion Terms & Conditions

### 1. Sponsor

This promotion ("Promotion") is sponsored by **Alinea Invest, Inc.** ("Alinea"), [insert business address].

## 2. Eligibility

This Promotion is open to legal residents of the fifty (50) United States and the District of Columbia who are at least 18 years old and have successfully created an Alinea account and completed all required identity verification (KYC). Employees, officers, and directors of Alinea, its affiliates, and their immediate family members or members of the same household are not eligible to participate.

#### 3. Promotion Period

The Promotion begins on 11/11/25 and ends on a date decided by Alinea. (the "Promotion Period").

# 4. How to Qualify
