## TERMS & CONDITIONS 2026

### **Codes of Conduct & Policies**

By registering a junior player with Balgownie Junior Football Club (Balgownie JFC), the parent or legal guardian confirms that they have read, understood, and agree to comply with all applicable Codes of Conduct and policies issued by:

- Football Australia
- Football NSW
- Football South Coast
- Balgownie Junior Football Club

The parent or guardian further agrees to ensure that the registered player complies with these Codes of Conduct and policies at all times. Current versions of all Club policies are available on the Club website at [www.balgowniejuniors.com.au](http://www.balgowniejuniors.com.au).

### **Volunteering**

Balgownie JFC is a volunteer-run organisation. By registering a junior player, the parent or guardian agrees to receive communications from the Club requesting assistance with volunteer duties during the season. These duties may include, but are not limited to, canteen operations, ground marshalling, or other match-day and club support activities. Volunteer participation is essential to the effective operation of the Club and may be coordinated through a Club-managed volunteer roster system or club communication channels.

### **Registration Refunds**

Junior players who register with Balgownie JFC but do not participate in part or all the current season may be eligible for a refund of registration fees, subject to the circumstances. All refund requests will be assessed and processed in accordance with the Balgownie Junior Football Club Registration Refund Policy, which is available on the Club website.

At the time of registration, the portion of the registration fee payable to the governing bodies (Football Australia, Football NSW, and Football South Coast) is paid directly to those organisations. The remaining portion (the Club Fee) is retained by Balgownie JFC.

Balgownie JFC can only refund amounts paid to the Club and reserves the right to apply an administration fee. Refunds of fees paid to governing bodies are subject to their respective refund policies and may be issued in full, in part, or not at all. All refunds are processed via the online registration system.

### **Use of Images**

Photographs and video recordings of players participating in training sessions, matches, or Club events may be captured during the season. These images may be used by Balgownie JFC for promotional or communication purposes, including publication on the Club website and official social media channels.

Requests for the removal of images may be submitted in writing to the Club Secretary and will be considered promptly.

Balgownie JFC recognises the sensitive nature of a participant's name, likeness, and audio-visual image (Image). Where an Image involves a child, the Club will only collect, store, and use such Images in strict accordance with the Football Australia Safeguarding Policy, including sections 5.4 (Taking Images and Videos of a Child) and 5.5 (Use and Storage of Images and Videos of Children).

### **Policies & Procedures**

Balgownie Junior Football Club reserves the right to amend, update, or replace its policies and procedures from time to time, in accordance with the Balgownie JFC Constitution. Such changes may occur during the season and will take effect upon publication by the Club.

### **Breaches**

Any breach of these Terms and Conditions may result in disciplinary action being taken by Balgownie JFC and/or the relevant governing bodies, including Football South Coast, Football NSW, or Football Australia, in accordance with their respective regulations and disciplinary frameworks.
