

# Product Specific Terms (PST)

## Platform Integrations / Uberall Connect



Last Updated: May 16th, 2025

Insofar as and to the extent that the subject matter of an Order includes the use of the SaaS Product **Platform Integrations** or **Uberall Connect**, such use shall be subject to these PST which are deemed an integral part of such Order.

Capitalized terms used but not defined in this PST have the meanings given to them in the Agreement.

### 1. PRODUCT-SPECIFIC RIGHTS & OBLIGATIONS

- 1.1. **Platform Integrations** within the meaning of these PST means the SaaS Product "Platform Integrations" or "Uberall Connect" as described in the Agreement.
- 1.2. **Connection to Connected System.** Platform Integrations may allow Customer to establish a connection ("Connection") between the SaaS Product platform of Uberall and a system and/or file of or used by Customer agreed upon by the Parties ("Connected System") or a Connected System for which Platform Integrations is generally made available by Uberall for the purpose of transferring types of data and/or files defined by Uberall ("Included Datatypes") from the Connected System to (available for Basic and Advanced product plan of Platform Integrations) and/or from (only available for Advanced product plan of Platform Integrations) Uberall through the API(s) of the respective Connected System ("Connected API(s)"). The establishment of a Connection may require an accurate API documentation of the Connected API(s) which Customer shall provide to Uberall upon request. Customer shall reply to any reasonable requests or inquiries in regards to such API documentation(s) without undue delay. The Parties acknowledge that any Connection established through Platform Integrations may not result in any real time synchronisation.

- 1.3. **Maintenance by Customer.** Certain Connections may require the creation of accounts for the Connected System and/or the maintenance of such accounts and/or providing Uberall with access to such accounts, each which shall, if applicable, be ensured by Customer. The Parties may determine field and file format(s) or matched

data point(s) for the Connection ("Data Source Structure"). In that event Customer shall not change the Data Source Structure or its field and file formats without the prior approval of Uberall in written form or text form. Uberall shall not be responsible for any loss or reduction of functionality of Platform Integrations and/or other SaaS Products resulting from any failure of Customer to comply with this provision.

- 1.4. **Cooperation of Customer.** Customer acknowledges its participation and cooperation is critical for the establishment of a Connection and failure to provide such may lead to changes of the timeline of the establishment of a Connection. Customer shall provide any reasonably requested acts of cooperation, which includes in particular acts of cooperation in regards to the testing of an established Connection, without undue delay.

### 2. TERMINATION

- 2.1. **Termination of Platform Integrations.** Notwithstanding the Term, the Parties agree that, in the event that Platform Integrations, as agreed upon in the Order, is charged for with separate fees, Uberall may terminate only the part of the Order regarding Platform Integrations and/or the right of Customer to use Platform Integrations, at any time with 14 days notice with effect to the end of the then-current contract year of the Initial Term or Renewal Term, as applicable.

- 2.2. **Effect of Termination.** Any Connection(s) will not be usable from the point of time from which onwards Platform Integrations is not provided under an Order anymore. Any other part of the Agreement shall remain unaffected by a termination of only the part of an Order regarding Platform Integrations and/or the right of Customer

to use Platform Integrations as set forth in Section 2.1 above.

**3. MISCELLANEOUS**

**3.1. Hierarchy.** In any event of a conflict between the provisions of these PST and any part of the Agreement directly referenced in the Order other than the Order itself, these PST shall prevail but only with respect to the respective conflict.

**3.2. Changes.** Subject to and in compliance with the respective provisions of the Agreement, this PST, either individually or together with other parts of the Agreement, may be updated or amended by Uberall at any time.
