

# Product Specific Terms (PST)

## Insights & Analytics, GEO Studio & GEO Pulse



Last Updated: June 5th, 2026

Insofar as and to the extent that the subject matter of an Order includes the use of the SaaS Product **Insights & Analytics** and/or the SaaS Product **GEO Studio** and/or the SaaS Product **GEO Pulse** such use shall be subject to these PST which are deemed an integral part of such Order.

Capitalized terms used but not defined in this PST have the meanings given to them in the Agreement.

### 1. PRODUCT-SPECIFIC RIGHTS & OBLIGATIONS

1.1. **Definitions.** In these PST the following capitalized terms have the following meaning:

(a) **Insights & Analytics** means the SaaS Product Insights & Analytics as described in the Agreement.

(b) **GEO Studio** means the SaaS Product GEO Studio as described in the Agreement.

(c) **GEO Pulse** means the SaaS Product GEO Pulse as described in the Agreement.

(d) **Reports** means any reports and/or analytical visualizations provided through the SaaS Products.

1.2. **Reports and Analytics Data.** The SaaS Product Insights & Analytics allows Customer to view Reports created based on Customer Data and/or data of Uberall and/or third parties. Customer consents to the use of Customer Data for this purpose. In the event and to the extent Customer Data has been used for the creation of Reports, Customer's ownership of such Customer Data shall remain unaffected. In the event and to the extent that data sets and/or visualizations were created on the basis of aggregated and/or anonymised Customer Data, the Parties agree that Uberall is the sole owner of the created data.

### 2. GEO STUDIO & GEO PULSE

2.1. **GEO Pulse.** In the event that GEO Pulse is provided under the Agreement, Customer will be provided with Reports on various metrics regarding citations and visibility of the brand of Customer or its Corporate Locations in searches of third party artificial intelligence (AI) platforms ("**AI Platforms**").

2.2. **Prompts.** In the event that GEO Studio is provided under the Agreement, Customer may use GEO Studio to (a) receive and/or monitor information on mentions, and citations regarding the Customer or its brand in searches AI Platforms as well as the sentiment of such and/or (b) generate Module Output (as defined the PST AI-powered Features & UB-I) through by executing prompts ("**GEO Prompts**") within GEO Studio. For any generation of Module Output, the PST AI-powered Features & UB-I shall be applicable together with these PST.

2.3. **Credits.** Any execution of a GEO Prompt in GEO Studio requires payment with credit(s) intended for this purpose ("**GEO Studio Credit(s)**"), whereas the number of required GEO Studio Credits per GEO Prompt depends on various factors (which may include but not be limited to the number of AI Platforms addressed by the GEO Prompt, the number of Corporate Locations covered by the GEO Prompt, the number of personas addressed in a GEO Prompt or if the GEO Prompt is expanded into multiple, more specific subqueries suggested by Uberall (Fan Out)) and can be viewed within the SaaS Products. The Parties may agree in the Order on the purchase of an included amount of GEO Studio Credits ("**Included GEO Studio Credits**"). In the event that Customer has used up any purchased GEO Studio Credits, Uberall will allow Customer to purchase additional GEO Studio Credits ("**Additional GEO Studio Credits**"), either through the SaaS Products or by conclusion of an additional Order or amendment to an existing Order.

**2.4. Standalone Online GEO Studio Subscription.**

In the event that a Customer that is not contracted to Uberall for any other SaaS Products of Uberall subscribes to a monthly or yearly subscription (“Subscription Period”) for GEO Studio on the website of Uberall, such Subscription Period will automatically renew for another Subscription Period of the same duration, unless Customer terminates the subscription before the end of the then-current Subscription Period. Any unused Included GEO Studio Credits for a Subscription Period expire at the end of such Subscription Period and cannot be used for any subsequent Subscription Periods, unless the Parties agree otherwise in writing.

**3. RECOMMENDATIONS**

In the event and to the extent that the Reports contain recommendations regarding the use of the SaaS Products, Customer Data and/or other potential actions of Customer, the Parties acknowledge that such recommendations shall solely be considered as non-binding visualizations and/or demonstrations of potential activities or modification. Customer acknowledges that Customer shall have the sole responsibility for any business decision or other decision made based on such recommendations. Uberall shall not be liable for any business decision or other decision made by Customer based on such recommendations. The Parties agree that the SaaS Products do not include any consulting services or comparable other Professional Services or services.

**4. MISCELLANEOUS**

**4.1. Hierarchy.** In any event of a conflict between the provisions of these PST and any part of the Agreement directly referenced in the Order other than the Order itself, these PST shall prevail but only with respect to the respective conflict.

**4.2. Changes.** Subject to and in compliance with the respective provisions of the Agreement, this PST, either individually or together with other parts of the Agreement, may be updated or amended by Uberall at any time.
