

# Reservation Agreement

The undersigned hereby wishes to reserve a Hush Cycles Superior GT motorcycle against payment of a reservation fee of €3,000 and Hush Cycles AG, Herrliberg/Switzerland, hereby undertakes to sell to the undersigned one Hush Cycles Superior GT motorcycle substantially in the form as described in the description attached at the usual retail price charged for the motorcycle at the time of market readiness, as per the terms hereof. and Hush Cycles AG, Herrliberg/Switzerland, hereby undertakes to sell to the undersigned one Hush Cycles Superior GT motorcycle substantially in the form as described in the description attached at the usual retail price charged for the motorcycle at the time of market readiness, as per the terms hereof.

The undersigned is aware that the development of the Hush Cycles Superior GT motorcycle is currently only at the project study and prototype stage and that there is no certainty that the project will be successfully completed, that the motorcycle will be in the form or at the price as presented in the prototype, that it will be approved for road use, or that series production will subsequently be possible or viable. Should Hush Cycles AG manage to bring the Hush Cycles Superior GT motorcycle to approval for road use and to series production and have at least 300 Hush Cycles Superior GT motorcycles manufactured, the undersigned will be notified to the address indicated hereinafter and thereafter has the right to acquire one Hush Cycles Superior GT motorcycle within 60 days after notification or such longer period the parties may subsequently agree. The exercising of the purchase right has to be notified to Hush Cycles AG in writing. Should the purchase right not be exercised within these 60 days or a longer period mutually agreed, it becomes nil and void and the advance payment of €3,000 is forfeited. The deposit of €3,000 will not bear interest. In case the purchase right is exercised, the amount of €3,000 will be deducted from the purchase price. Should Hush Cycles AG not be successful to bring the Hush Cycles Superior GT motorcycle to approval for road use and to series production and have at least 300 Hush Cycles Superior GT motorcycles manufactured, the advance payment of €3,000 is lost and will not be repaid to the undersigned.

This reservation agreement is subject to Swiss law (without its international private law rules) and exclusive venue for all disputes is Herrliberg/ZH, Switzerland. It becomes effective (i) upon reception of this duly completed and signed form by Hush Cycles AG and (ii) reception of an amount of €3,000 (three thousand) on the following bank account:
