CONFIRMATION

CANCELLATION

If cancellation occurs within 5 business days prior to the event, the client will be charged 100% of any prearranged catering.

FINAL NUMBERS AND DETAILS

Please note we require a minimum of 5 business days' notice for final guest numbers & catering options, along with your serving time and event title. Final payment must be settled no later than 5 business days' prior to your event.

PAYMENT
