FOR CLARITY, WE GROUP CLIENTS INTO FOUR BROAD RISK AND PRICING TIERS. TIER 1 COVERS STANDARD CORPORATES AND PROFESSIONAL SERVICES FIRMS OPERATING IN LOWER-RISK JURISDICTIONS. TIER 2 COVERS CROSS-BORDER SMES AND GROWTH-STAGE BUSINESSES WITH HIGHER VOLUMES AND MULTIPLE MARKETS. TIER 3 APPLIES TO OFFSHORE ENTITIES AND OTHER HIGHER-RISK VERTICALS SUCH AS FX DESKS, PERFORMANCE AND AFFILIATE MARKETING OR COMPLEX STRUCTURES. TIER 4 IS RESERVED FOR CRYPTO, IGAMING, PSPS AND OTHER VERY HIGH-RISK MODELS WHERE THE COMPLIANCE WORKLOAD, MONITORING EXPECTATIONS AND PARTNER REQUIREMENTS ARE MATERIALLY HIGHER.
