LANCASHIRE AND SOUTH CUMBRIA TRAINING HUB

Q4 18/19

The purpose of this report is to present high level information for the Lancashire and South Cumbria Training Hub about facilitated student placements and their spread in the 5 locality hubs. Future reports will be following the quarterly report submissions to HEE.
