

# QUARTERLY REPORT

## LANCASHIRE AND SOUTH CUMBRIA (LSC) TRAINING HUB

### Q1 19/20

The purpose of this report is to present high level information for the Lancashire and South Cumbria Training Hub about facilitated student placements in general practice and their spread in the 5 locality hubs. The reports follows the quarterly report submissions to HEE.

This report presents data from the first quarter of 2019/2020 financial year versus the previous four quarters and, where appropriate, a baseline from the start of the project in September 2015. While we are unable to present detailed data from the years 2016 and 2017, the numbers below show the growth of the Training Hub during the pilot phase.
