

## **St. Vital Centre's Social Media Contesting Rules and Regulations**

- 1. CONTEST PERIOD:** St. Vital Centre runs many contests through its social media platforms throughout the year. For these Contests, the Contest Period, duration, and timing will be identified by St. Vital Centre at the time of the Contest.
- 2. ELIGIBILITY:** Entrants must be residents of Manitoba. Employees, principals, representatives or agents of Leyad St. Vital Centre Holdings Inc. and its affiliates, immediate families of any of the foregoing, and employees of St. Vital Centre retailers are not eligible to win. The Contest is also not open to previous prize winners who have won a prize through St. Vital Centre's social media platforms in the preceding thirty (30) day period prior to the commencement of another Contest on social media.
- 3. HOW TO ENTER:** To enter for a chance to win a Contest, follow the instructions given by St. Vital Centre to find out how to enter and win a prize. Each contest may vary in nature, but will typically be a response to a question posed by St. Vital Centre. The response may require text, photo, video, use of a specific hashtag, or any combination of the aforementioned.
- 4. PRIZES:** Prize will be announced by St. Vital Centre at any point during the Contest. The approximate retail value of a prize can vary and is available upon request at the time of the particular contest. Sponsors and St. Vital Centre reserve the right, in their sole discretion; to substitute any and all of the prizes for prizes of equal or greater value should all or part of the prize become unavailable for any reason. Winners will be selected by St. Vital Centre's discretion or selected by random out of all entries during the Contest. Each eligible winner will be notified through the social media platform used to host the contest with instructions for confirming eligibility and claiming prize. If a winner does not respond to St. Vital Centre within 48 hours of being contacted, the winner will be disqualified and an alternative winner may be selected.

The odds of becoming a winner will depend upon the number of eligible entries submitted and the content of the answer. Potential prize winner will be required to answer, without assistance of any kind, whether mechanical or otherwise, a time limited, mathematical skill-testing questions, provide identification satisfactory to the representative of St. Vital Centre and sign an acknowledgement and release form prepared by St. Vital Centre.
