The Chairperson called the meeting to order at: 9:15 am

- **1.0** Chairperson discussed the most effective process moving forward would be to keep the one "Collective" Group Meetings going forward without adding Committee Meetings, since both meetings are attended by the same members.
  - a. All meeting minutes and action items will be distributed to everyone.
  - b. A spreadsheet with all the concepts and ideas to track them and brought into focus for greater discussion.
  - c. Priority is to complete the Additions to Reserve (ATR) process without losing sight of the discussion to date.
  - d. Plan to hold a Strategic Planning Session to establish values and vision of the properties will be critical moving forward.

## 2.0 Updates from the March 3, 2022 Committee Meeting Minutes

### 2.1 Purpose of Committee

- a. Focus on completing the ATR
- b. Outline the potential structure:
  - Potential free legal assistance may be leveraged through the Land Advisory Board (LAB) with 19/21 in land code; 2 in development stage.
  - Identify if there are consultants and resources for funding opportunities.
- c. Record keeping: Minutes, Action Items, and the Collective's Land Use Concepts and Ideas Spreadsheet will be recorded and shared.

#### 2.2 Structure

- a. LAB may be able to provide experience with collective initiatives and be able to provide suggestions on structure and voting rights.
- Language in Land Code to include the 3 properties.
   LAB: legal language for land code amendments pending.

#### 2.3 Administration

- a. Willy Hall and staff have offered administrative support until the Collective Administration is established.
- b. Legal assistance pending from LAB.

### 3.0 Chairperson's recap and closing remarks

- LAB will look at financial support for amending codes and voting requirements the result will be circulated to the collective. If support is not provided, the collective will take recommendations, if any, on someone who is knowledgeable with land code, structure, and entity.
- Other funding opportunities: \$600,000 held in trust back to the entity, Indigenous Services Canada (ISC), and New Relationship Trust (governance).
- Highest and Best Use study will come at a later date.
- Secretariat will be Stó:lō Nation for now, providing administrative support; meeting minutes, communication with LAB and others and ensuring information is shared.
- Create and maintain the "Collective Lands Concepts and Ideas" spreadsheet.

- Create a Collective Management Plan; Coqualeetza, Pekw'Xe:yles, and Xá:ytem.
- Review BCR at next meeting.
