The Company is taking effective steps to put in place digital training modules and has also significantly reduced the operating costs. The management will continue to closely monitor any material changes arising out of future economic conditions and impact on its business.
- 5 The company has a single segment namely "Training". Therefore the company's business does not fall under different operating segments as defined by
