

SENIOR MANAGEMENT

The Senior Management Team consists of the Commissioner and Executive and Officers In Charge of the various units or sections of the Samoa Police. The Officers In Charge (OICs) are those holding Commissioned Officers ranks (Superintendents and Inspectors) and Principal Officers from the Corporate Service.

OVERVIEW OF OPERATING PERFORMANCE AND RESULTS

This annual reports highlights the work done by the various areas of the Samoa Police Service at the operational, corporate and executive level.

1. PROFESSIONAL STANDARD UNIT (PSU)

The PSU investigates all complaints against members of the service. It works collaboratively with the Office of the Ombudsman and the Attorney General Office on issues of police discipline and general ethical behavior of all SPS staff except for the Executive.

The Unit's performance during FY 2016/2017 is recorded in the table below.

The Professional Standard Unit performance during the financial year in terms of their response to complaints (internal and external) was reduced to 29% overall. Complaints against members of the service have reduced to 37% in comparison to the previous financial year. Internal complaints have reduced to 60% during the financial year.

The reduction in matters handled by PSU is due to the implementation and enforcement of internal systems and processes as well as enhancement of partnership with other stakeholders. There has been an increase in community awareness encouraging the public to report unethical behavior of members of the service.

2. LEGAL UNIT

The Legal advisor (LA) is responsible to the Commissioner of Police and the Executive; and seeks to provide advice on legal implications affecting the Ministry in the execution of its statutory functions.

The LA works closely with the Office of the Attorney Generals on all legal matters affecting the Samoa Police Service. At the advice of the Commissioner and Executive the LA also facilitate amendments of relevant legislations and regulations. One of the amendments to the Police Service Regulation 2010 includes the insertion of the following;

(a) Employment of near relative within the Samoa Police service

The LA's contract finished in October 2016. Since then the Attorney General's Office provided direct legal assistance.

3. INTERNAL AUDIT UNIT

The Internal Auditor (IA) is responsible to the Commissioner of Police and provides advice on the appropriate utilization of resources and guidelines as per Government requirements. The auditor is also responsible for mandatory spots of checks of all areas to ensure that all members adhere to internal policies and comply with internal controls.

The performance for the last quarter of this reporting period is shown in the Table 2 below.

During this reporting period the Samoa Police service hired an internal auditor to enforce and monitor compliance to auditing guidelines required of the relevant Government Ministries. This ensures transparency in the utilization of government resources and funding allocated to the Samoa Police service.

4. GENERAL POLICING UPOLU

General Policing Upolu consists of Uniform Policing Apia and the entire police outpost on Upolu Island. Uniform policing are responsible for investigation of crimes with imprisonment penalties of 7 years or below. They are also responsible for all frontline duties as first responders to community issues. They work in collaboration with stakeholder partners such as village councils, church leaders and NGOs to prevent crimes and protect vulnerable members of the community. Furthermore police outposts promote police visibility around Upolu.

The performance of the Unit in the last quarter of this reporting period is shown in the Table 3 below.

5. BAND UNIT

The Police Band is responsible for the provision of band services for all government official functions. The Band is responsible for the daily parade for raising the flag in front of the FMFM II Building at Eleele Fou. Band members are usually sworn officers and are therefore deployed to provide support services to other Units in the Samoa Police, to assist in crowd control duties, search and rescue, traffic duties and communications support. It also serves as a key component in some of the Ministry's Community Engagement Programs. The main activities carried out by the Band Unit in FY 2016/2017 were morning parades and general police duties.

6. DOG MANAGEMENT UNIT (DMU)

The DMU is responsible for the management of functions stipulated under the Canine Control Act 2013. These functions include the; impounding and registration of dogs, assist the Animal Protection Society for their de-sexing programs. This is to ensure community health and safety, and to minimize the issue of stray dogs which impacts greatly on our tourism industry.

7. COMMUNITY ENGAGEMENT UNIT (CEU)

The CEU works in partnership with other stakeholder partners to deliver community safety messages and programs to reduce crime and enhance the quality of life within Samoa. These programs include media awareness campaign, school visits, community engagement visits, church visits, cyber safety awareness initiatives. These initiatives encourage community cohesion, crime preventions strategies and their understanding of the general laws of Samoa.

The performance of the CEU in the financial period 2016/2017, as noted below, highlights its annual activities.

8. CRIMINAL INVESTIGATION DIVISION (CID)

CID deals mainly with investigation of major criminal or serious cases with imprisonment penalties of 7 years and above reported to the police. This division works closely with the Office of the Attorney General in ensuring prosecution briefs for Supreme Court cases are prepared and witnesses are available for court hearings to ensure successful prosecution of cases that are of a concern to the community.

The performance of the CID in the financial period 2016/2017, as noted below, highlights its annual activities.

This table shows a significant reduction in five of seven performance indicators compared to the previous reporting period (i.e.) Sexual, Homicide, Violent, Burglary & Theft and Public Safety Offences.

However, a dramatic increase in two performance indicators- narcotics cases and crimes against property, recorded in this reporting period which shows the great work by the Community Engagement Unit in weekly awareness programs on the media to assist the community in reporting these crimes.

9. DOMESTIC VIOLENCE UNIT (DVU)

The Domestic Violence Unit is responsible for administration and implementation of the Family Safety Act 2013. This unit assists families affected by violence and works collectively with relevant stakeholder partners to prevent ongoing violence affective victims and vulnerable members. It is also responsible for issuance of Interim Protection Orders and serving of Protection Orders issued by the Family court.

The Domestic Violence Unit works closely with the Family Court and also with stakeholder partners like the Samoa Victim Support Group in supporting victims of crime.

The performance of the DVU in the financial period 2016/2017, as noted below, highlights its annual activities.

10. FORENSIC UNIT

The Forensic Unit's supports police investigations with the provision of scientific evidence to support or negate possible theories involving physical evidence found at a crime scene. Forensic staff analyzes evidence gathered and/or received from crime scenes and presented their findings based on the results of their analyses. They are also responsible for documenting all criminal results after court proceedings handled by the Attorney General's Office.

The performance of the Forensic Unit for the financial period 2016/2017, as noted below, highlights its annual activities.

As shown above there has been a increase in the Police reports and photographs produced for court proceedings. This is an increase in revenue for the Police and the amount of cases handed over to National Prosecution Office for the Court.

11. TACTICAL OPERATIONS SECTION (TOS)

TOS is responsible for responding to high risk planned and emergency operations and provide close personal protection security for VIPs, siege and hostage situations, as well as responding to armed or dangerous situations. Officers are trained on use of specialized tactical skills.

The performance of the TOS for the financial period 2016/2017, as noted below, highlights its annual activities.

12. POLICE MARITIME UNIT

The Police Maritime Unit undertakes the followings duties;-

- Responding to Crime and disorder attending, investigating and reporting offences, apprehending offenders in relation to stolen boats, protest activity on the water.
- Protecting boaties from water-based dangers, crime and reckless behavior, maintaining security checks on international cruise ships.
- Search and rescue sea operations
- National security through joint enforcement patrols with other government agencies such as Customs, Shipping and others.
- Supporting police on land and transporting police by sea to remote locations for cases
- Enhancing boat safety through awareness and training for maritime officers
- Body recovery, medical emergencies and other activities

Members of the Police Maritime Unit also assist with Policing and land based operations.

The performance of the Maritime Unit for the financial period 2016/2017, as noted below, highlights its annual activities.

This unit provides communication support to the whole Police service. It receives incoming calls and 995 emergency calls. They work closely with the Disaster Management Office and liaise with local communication network to provide ways to improve connectivity of telecommunication.

15. CANINE UNIT (K9)

This Unit is responsible for undertaking functions specific to the Police K9 Unit specified in the Police Powers Act 2007 and other related Acts. These functions include: deployment of K9 to detect narcotics including cocaine, marijuana and chemicals used to make cocaine. The K9 unit works in collaboration with the Immigration and Customs Ministries at the airports and wharves and freight services companies.

The Human Resources Management and Mission Unit manage and monitor all related human resource matters. It oversees all phases of the Recruitment and Selection process, Conditions of Service and Entitlements, Performance Appraisals and facilitates all personnel issues including salaries, transfers, allowances and members' benefits, safeguards and maintains personnel files, records and conduct overseas mission recruitment.

It conducts the recruitment of peacekeepers and work in collaboration with the Training Unit, United Nations Department of Peacekeeping Operations and the Samoa Permanent Mission in New York for the deployment of police officers to overseas peacekeeping missions.

The performance of the HRM for FY 2016/2017 reported below reflects its annual activities.

21. TRAINING AND DEVELOPMENT SECTION

The Training Section is responsible for capacity development of all member of the Police service. It provides basic training to new police recruits, refresher trainings, rank qualifying trainings and specialized training and facilitates selection of staff for overseas and local trainings. It works closely with the Public Service Commission, Ombudsman Office and Attorney General's Office on ways to improve policing services through targeted trainings such as Human Rights, Police Powers etc.

The Training also works collaboratively with the Samoa Australia Police Partnership in its undertaking of capacity building.

The Training Section also facilitates all internal training for all police officers in preparation for the United Nations Selection and Assessment (UNSAAT).

GOVERNMENT COMMITMENTS

The Samoa Police Service is also committed to fulfilling Samoa Government commitments and priorities during this reporting period. These commitments include active participation of police members through Police Operation Orders to provide security and safety of participants. These included the following;

1. GREEN CLIMATE FUND MEETING

The Government hosted this meeting which was attended by 400 government dignitaries and United Nations officials. The purpose of this meeting was to assess the situation of Samoa that was affected by Cyclone Evan. The Special Event Unit, led by Senior Sergeant Ituau Ale, presented a recorded video highlighting the issues encountered by the Ministry in its response to the Cyclone.

2. GOVERNOR GENERAL OF AUSTRALIA (30 June-2 July)

The Governor General of Australia, Hon Sir Peter Cosgrove and Lady Cosgrove, visited Samoa and stayed at the Taumeasina Island Resort. Due to the high level visit the delegation were provided with full Police escort and security for the duration of their stay. The Governor General's visit focused on the strong bilateral, development and people links between both countries. The itinerary for the visit included a cricket match, a visit to Aele Fou, the opening of the Leone Bridge and the opening of the Australian Aboriginal Art Exhibition.

3. NEW ZEALAND PRIME MINISTER BILL ENGLISH'S VISIT

Samoa hosted the Prime Minister of New Zealand, Rt. Hon. Bill English, Mrs. English and members of his Cabinet and Parliament. The Ministry of Police provided the usual courtesy of full escort and security for this visit with notable success. Prime Minister Bill English's visit played a significant milestone in strengthening the relationship between the two countries.

4. QUEENSLAND REDS vs AUCKLAND BLUES RUGBY GAME (2 June 2017)

Manu Samoa hosted this second night game at the Apia Park. The Ministry of Police successfully covered the security and safety of the public throughout the duration of the game.

STATUS OF CRIME IN SAMOA FY 2016-2017

Samoa Police Service focused on reducing rates of crime, particularly violent crime. Enhanced frontline policing and effective targeting of crime hot spots and repeat offenders contributed significantly to positive trends in the status of crime in Samoa from FY 2014/2015 to FY 2016/2017. A decline in, or maintenance of , crime levels across all key indicators, overall and in type of crime, in this reporting period, are illustrated in Graphs 1 to 6.

Note that recorded crime statistics represented only those matters reported to Police. A change in recorded crimes may reflect changes in the tendency to report to Police.


Graph 1: OVERALL INCIDENTS REPORTED


Graph 2: NUMBER OF INCIDENTS RECORDED FOR SEXUAL CRIMES

For this reporting period, dramatic decrease in number of incidents of sexual crimes recorded




Graph 3: NUMBER OF INCIDENTS RECORED FOR CRIMES AGAINST PERSONS

Although a slight increase in incidents of possession of narcotics from those of FY 2015/2016, a dramatic decrease from those of FY 2014/2015; more than 50% reduction in incidents of cultivation of narcotics. This reporting period began to record incidents of possession of seeds and possession of utensils.

FINANCIAL REPORT

Budget Analysis

Approved Estimates:

The overall government budgetary funding of \$23.3m was appropriated to the Ministry of Police for the reviewed financial year. Of this total amount, \$21.3m was allocated for Outputs provided by the Ministry, \$1.96m for Transactions on Behalf of the State and \$0.35m for Cost Recoveries. This was an increase of 1.7% from the previous financial year. Such increase was the result of the addition of \$0.650m, under Transactions on behalf of the State, for Police Uniforms.

Actual Spending:

At the end of the reviewed financial year, the MOP had expended 97.5% (\$22.7m) of its total appropriation. As a consequence of the low utilisation rate of the Personnel Budget due to unfilled positions in the Ministry and the Dog Management Lease, this results in \$.578m unexpended funds.

Outputs Provided by the Ministry:

Of the \$21.3m approved, only \$0.522m remained unexpended. The majority was committed as follows:

1. Personnel Spending

76% (\$16.1m) of the abovementioned \$21.3m was appropriated for personnel expenditure. However, identified savings were realized as a consequence of the high staff turnover throughout the year. These savings were vired to cater for capital and operational expenditure and staff benefits.

Regrettably, at year end, the unexpended (remaining) personnel funds still amounted to \$0.32m. These funds were for unfilled positions. Unforeseen circumstances led to this non utilisation.

2. Operating Spending

3% (\$0.141m) remained unutilised of the total approved Operating budget of \$4.8m. This was due to the re-shuffling of Ministerial portfolios as well as the late approval of the Ministry's virement requests submit to Treasury to cater for expenditures incurred towards the end of the Financial Year.

3. Capital

The Ministry strategized to expend available savings to procure needed capital items, most of which were replacements of old obsolete office equipment. During the reviewed year, \$0.27m worth of office equipment, tools and furniture were procured.

Transactions on Behalf of the State

A total of \$1.96m was appropriated for this category. However, only \$1.905m was expended on activities noted below, leaving a balance of \$0.055m

1. Overseas Peace Keeping Missions

\$0.181m was expended on the preparation of peacekeeping missions to South Sudan and the purchase of capital items, approved by Cabinet, for UNSAAT local training.

2. Leases:

In strengthening the Ministry's outreach service and response in the rural areas, \$0.028m was paid for renewed land leases for Police Outposts in Lotofaga, Lalomanu and Vaitoomuli. \$0.040m for the Dog Shelter at Vaitele and \$0.044m for our Minister's office at the FMFM II Government Building.

3. Police Outposts

Ongoing maintenance and renovations work were carried out for the Ministry's outposts in rural areas, in both Upolu and Savaii, with total expenditure of \$0.189m.

4. Hiring of Vehicles

\$0.024m was expended on the hiring of vehicles needed for special operations and special raids conducted within this financial year.

5. Uniform

99.9% of the allocated funds for Uniforms was utilised over the 12 months of this financial year, in procuring Police official uniforms as well as surveillance uniforms required for the Ministry's special operations.

COST RECOVERY

\$0.525m was collected by the Ministry in this financial year. Compared to the \$0.353m cost recovery projections, the Ministry of Police far exceeded its projected target by 149%, an equivalent of \$0.171m in monetary terms. It is noted that the Ministry's cost recovery collections depended heavily on the demands from the public as elaborated below:

- 1. High demand for:
 - 1. Police Clearance reports
 - 2. Insurance reports for Traffic offences and lost properties,
 - 3. Bingo, Raffle, Promotions and Bonus permits
- 2. Registration of Dogs; and
- 3. Armoury's Arms Permits and Dealers licences.
