Strategy Highlights



Our Zero strategy, used in the Alpha Low Volatility Fund, is a non-directional strategy seeking non-correlated returns independent of traditional equity and fixed-income markets. The strategy was designed to deliver a sophisticated cash management tool for investors that allocates capital among multiple strategies to purchase and sell derivatives of fixed-income and volatility securities and ETFs.



Objective

Steady premium capture + T-bill yield with capital preservation and monthly liquidity



Base Capital

Held in short-term government treasury ETF for liquidity & yield (SGOV)



Laddering

Bi-weekly entries smooth exposure and reduce timing risk



Overlay

~10% of buying power sells 30-day 40-50% OTM volatility calls (e.g., UVXY, SQQQ)



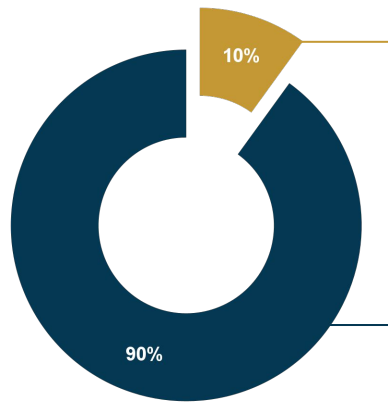
Risk Response

If volatility spikes, positions are closed and re-entered post mean reversion (3-5 days)

Portfolio Role

The Low Volatility Fund was developed to provide enhanced fixed-income returns irrespective of market direction as an efficient cash alternative beyond money markets.

PORTFOLIO COMPOSITION



Bi-weekly call options

- Seeks to capture small wins every week throughout the year
- Returns are the result of the natural price decay of options over time

Short-term U.S. Treasuries

- Earns ~4% yield
- Seeks to provide downside protection and liquidity

INVESTMENT FRAMEWORK

- Preservation of capital is essential to the long-term success of our strategy
- High liquidity allows for quick trade execution and nimble adjustments to market shifts
- Low correlation with stock market & often performs best during volatility spikes
- Risk is managed both proactively by the Fund Manager and inherently by the trade structure
- Alpha Low Volatility Fund is designed for accredited investors seeking fixed income, and retirement accounts targeting enhanced growth with reduced volatility

Investment Process





Alpha Wealth Funds' systematic process for identifying, executing, and managing high-probability option trades across volatility and fixed-income markets.



Proactive Risk Management

Effective risk control begins with understanding each trade's downside. We attempt to manage exposure through proactive risk management, structured hedging, and disciplined position monitoring.



-  Positions hedged through structure and active monitoring
-  Liquidity maintained for quick trade execution
-  Pre-defined stop levels and profit targets
-  Capital can remain in cash during extreme volatility

Strategic Evolution Driving Consistency



2021–2023 early phase

The beginning of this fund was built around short-term Treasury base and far OTM index option overlays. Strategy proved effective in stable volatility but exhibited over exposure to volatility spikes.

2024 and beyond

Introduced enhanced monitoring, refined trade discipline, and reduced leverage to 10–20% overlays for improved downside protection.

Shifted toward higher-frequency, smaller exposures with near-strike spreads and proactive hedging designed to produce more steady returns across market environments.

What Changed & Why It Worked



Refined Trade Selection

Focused on repeatable, high-probability setups



Tighter Risk Controls

Proactive hedging and defined downside thresholds



Smaller, More Frequent Contracts

Lower concentration and faster turnover improved return smoothness



Adaptive Structure

Adjusts exposure dynamically with market volatility

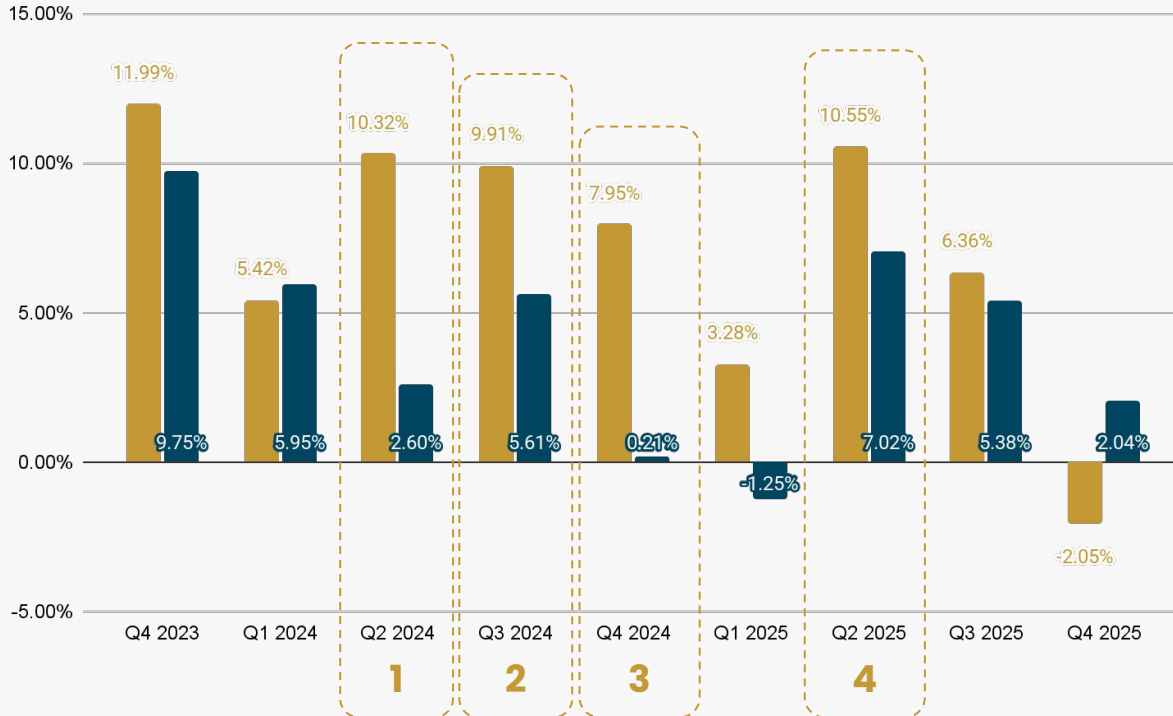

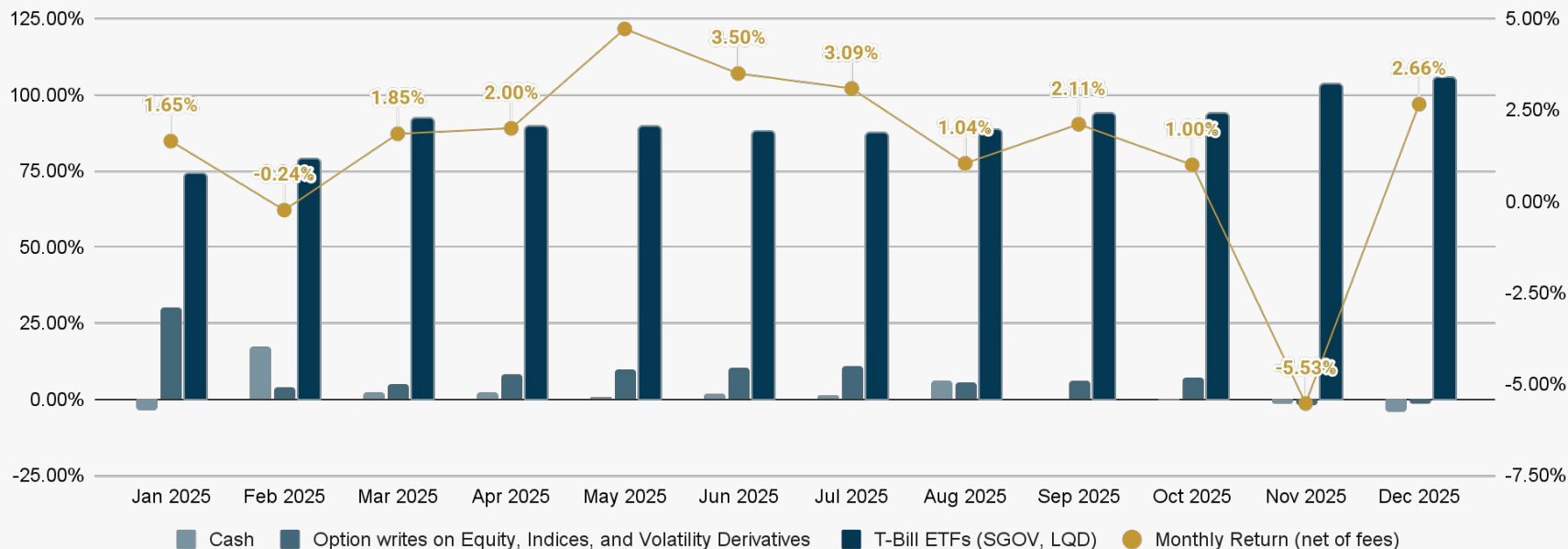
