"I further believe that I will possibly experience forgery and very possibly be convicted for it, from valid signatures made at service stations using credit cards. The customer gets the copy, the station keeps the hard copy, and the clear carbon with the valid signature is purchased or given away for framing purposes. These signatures are entirely valid and in court will be so appriased by any handwriting expert. This involves betrayal of a trust involving state taxes. ~~(X)~~

"I have stated the possibility of premeditated murder from the standpoint of the operator, his vehicle and add to this the same conditions for the other vehicles involved. These are manipulated by the 'rotten apples' in the barrel of any Federal security arm, who are untouchable because of betrayal of Federal top secrets they have sworn to defend. "I further believe this letter will be seized by the Post Office authorities, who already know its contents, if mailed, for what I consider obsolete security reasons. It must be transmitted by teletype, telephone or private carrier. ~~(X)~~

"Any smell, taste, hearing by sound or word, sight can be controlled by vision blocks or intensity of clarity or pin point control of eye direction itself. Any physical sensation can be duplicated. Mental and conversational blocks can be created at any time. Usually with public embarrassment to that person. Naturally mathematics, typing, book keeping can be manipulated to the extremes of frustration or nervous or mental collapse. Sexual climax can be made to most any individual anywhere or anytime. ~~(X)~~

"Any type machine can be manipulated, destroyed or damaged from unexplainable reasons or sources. This means any part or component of any part of that machine or motor-- regardless of kind or type. Any ignition system can be shorted at random. Previously the method used was connecting the ray to electric or telephone lines, which gave access to the monitoring of anyones thoughts wherever he may be, particularly while at work at your desk. Thoughts used on the highway while driving were monitored by equipment carried in trucks, rental trailers, autos, etc. Much of this equipment is from out of state, particularly California, used in the valley by non-tourists who are here for reasons extending over 30 days and who do not pay for Texas plates. ~~(X)~~

[redacted] furnished the following information on 12/30/66, classified "~~SECRET~~" with instructions that it not be disseminated in whole or in part outside the Bureau without prior approval [redacted]

"Attached for your information and retention is a copy of the text of a telegram addressed to the Federal Security Police, Mexico, D.F. The telegram was sent from Harlingen, Texas, by W. R. Hanawalt on 20 December 1966.

"The files of this office contain no information on Hanawalt other than the information contained herein."

The telegram is set out as follows:

Following letter sent to Officer in Charge, Texas Dept. of Public Safety, Harlingen, Texas

"Dear Sir, this letter is in way of clarification and to enlarge upon my accident report and the remarks contained therein dated this date and delivered to you personally.

"The laser ray, or cobalt ray is a self encroding ray, and is similar in use to a cocoon around a silk worm. The entire body is enclosed and the entire nervous system can be manipulated to a lesser or greater degree of proficiency than is normal. Visions of flying objects are merely faulty vision-fully controlled and is very real to that individual experiencing the phenomena. Breathing and heartbeat can be
