Earning Store Credit

You earn credit when you purchase a product or service from our retail offering. Loyalty Credit is earned at 1% of the VAT inclusive cost of the products and/or service you have purchased.

For any void and/or refunded purchases, we will deduct the store credit that you were awarded for that purchase.

OTHER

Loyalty Credit accumulated under the program are promotional and are not available as a cash value, cannot be redeemed for cash or gift cards/vouchers.

Your account is personal to you and may not be sold or transferred or assigned to anyone else

You may have only one GolfQube account

Without notice to you, GOLFQUBE reserves the right to suspend any Q+ account and/or your participation in Q+ Loyalty if we believe in its sole discretion that you have violated these Terms of Use, or that the use of your account is unauthorised, deceptive, fraudulent or otherwise unlawful.

GOLFQUBE may, in its sole discretion, suspend, cancel or combine accounts that appear to be duplicated. In the event that your participation in Q+ Loyalty is terminated, then all accumulated Points in your account are void.

Without notice to you, GOLFQUBE also reserves the right to “unregister” and make you ineligible for the Q+ program, If the account has been inactive for TWO year (24 Months). Inactive is defined as no Store Credit earned (No Purchases made). In the event that your account is unregistered or deleted, all accumulated credit in your account become void and will be deleted.
