Livestock Auction

All Large Livestock will be sold by the pound.

MAXIMUM PAY WEIGHTS
Swine 250 lbs. Sheep 150 lbs.
Steers 1300 lbs. Goats 100 lbs.
This is a TERMINAL SALE there will be NO LIVE PICK-UP!
Market prices for resale will be posted day of sale. Resale animals will be processed (NO LIVE PICK-UP), and buyers will receive the resale value on the day of the sale.

All Small Livestock (Rabbit Meat Pens) will be sold by the head.

Small Livestock will be processed, and must be picked up at the Fair Administration Office May 20 or 21. Any Animal not picked up will be donated to the local Foodbank.

Decisions to make as a Buyer! Resale

If you wish to support a young exhibitor by purchasing an animal but you do not want the animal, you mark **resale** on the sales invoice. With this method, you as the buyer will pay the difference between the price you bid and the market value of the animal on the day of the sale (market prices will be posted). You will not receive any meat nor will you take delivery of the animal. The animal will still be processed, and you will receive resale value for the animal.

The ONLY Animals available for Resale are: Swine, Sheep, Goat & Beef

Process

If you wish the fair to ship your purchased animal to a processing plant to be processed for your own use, you will mark process on the sales invoice. After processing, carcasses will be delivered to the meat locker specified for each specie, for cut and wrap. It is imperative that **you** contact the meat locker for your preference of cut and wrap, and that **you** pick up your meat as soon as possible. Meat not picked up in a timely manner will be donated to the local Foodbank.

The ONLY Animals available for processing are: Rabbits, Swine, Beef, Goats, and Sheep.

Payment Information

Payment is encouraged the day of the Auction. Payments can be made by Check or Cash. **No Credit Cards will be accepted.**Buyers will be invoiced after the Fair. After 30-days 1.5% interest will be assessed monthly on monies owed.

Any Payments not received after 60 days will be sent to Collections.
