#### 1. CALL TO ORDER

Vice President Pence called a meeting of the Board of Directors of the 23<sup>rd</sup>. District Agricultural Association at 7:00pm.

#### 2. FLAG SALUTE

Vice President Pence led the Flag Salute

#### 3. ROLL CALL/DIRECTORS ABSENT

Vice President Pence read Roll Call; All Directors were present.

#### 4. PUBLIC COMMENTS

There were various public comments from Brentwood 4H Parents and Exhibitors, as well as Delta Diablo 4H Parent, in regards to Steer Ownership Deadline, and Ownership Forms and Photos that were not turned in by the deadline.

#### 5. ACTION ITEMS

#### A. CONSENT CALENDAR

Vice President Pence asked for a motion to approve the minutes August 14, 2024, Board Meeting. It was moved by Director Dolphin, seconded by Director Sherwood to approve August 14, 2024, Minutes as presented. Motion unanimously approved.

Vice President Pence asked for a motion to approve 2024 & 2025 Interim Contracts including Base Camp Contract. It was moved by Director Sherwood, seconded by Director Dolphin to approve 2024 & 2025 Interim Contracts including the Base Camp Contract as presented. Motion unanimously approved.

Vice President Pence asked for a motion to approve Standard Contracts. It was moved by Director Dolphin, seconded by Director Hobin to approve Standard Contracts as presented. Motion unanimously approved.

#### **B. COMMITTEE REPORTS**

- 1. The Executive Committee had nothing to report.
- 2. Budget and Finance Committee
  - a. July, Aug, Sept, Oct, & Nov 2024 Financials The Budget and Finance Committee reported on the Financials. CEO Brengle went over the financials and additional reports. Vice President Pence asked for a motion to approve the financials as presented. Director Dolphin made a motion to approve the July, Aug, Sept, Oct & Nov 2024 Financials as presented, Director Noah seconded the motion. Motion unanimously approved. b. 2025 Budget The Budget and Finance Committee reported that they had reviewed the 2025 Budget CEO Brengle went over the Budget. Vice President Pence asked for a motion to approve the 2025 Budget as presented, motion seconded by Director Hobin. Motion unanimously passed.

#### 3. Livestock Committee

a. Livestock Exhibitor Handbook – CEO Brengle stated the Livestock Exhibitor Handbook was on the website, as of the 1<sup>st</sup> of Dec. At this time

Sandy Parson asked about sanctioning of Pygmy Goat Show, CEO Brengle stated based on the feedback at the September Livestock Wrap-Up meeting that not all clubs had Registered Pygmy Goats, and based on the National Pygmy Goat Association, we could not have non-registered goats show in a Sanctioned Show. CEO Brengle stated that he would work with Sandy Parson, on awards for Champion and Reserve Champion Pygmy Goat. b. Auction Update — CEO Brengle updated the Board on collection of auction payments and stated that there were currently three outstanding buyers, and he was going through the Small Claims Court process.

- 4. Building and Grounds Committee
  - a. Facility Project List CEO Brengle went over the project list and updated the Board.
  - b. Strategic Planning Goals:
    - 1. Homeless Issues
    - 2. Parameter Fencing for Fairgrounds CEO Brengle stated that there was no update, and that these goals. would remain on the agenda, as the committee and board will continue to address them.
- 5. Fair Attractions Committee CEO Brengle had stated that the Fair Attraction Committee had met and discussed bring in a named Tribute Band on Friday Night of Fair to try and increase attendance. Brengle stated that the 2025 Budget reflected the cost increase to bring in a named tribute band, and that he was working on finishing the entertainment booking.

#### 6. HERITAGE FOUNDATION REPORT

There was no representative from the Heritage Foundation present. CEO Brengle stated that the Heritage Foundation had not met since November, and that there were Heritage foundation Financials through Nov 1<sup>st</sup>, 2024, in the Board Packet.

Director Sherwood asked about the status of the letter to the Heritage Foundations regarding Carcass Contest. F&E representative Charles Southwick stated that he had discussed it with CDFA Legal, and they recommended that the Board send a letter to the Heritage Foundation to stop their involvement with the Carcass Contest, and if this did not end in any results, then CDFA Legal would send a letter. CEO Brengle stated that he would draft a letter for the Boards review at the February Board Meeting.

#### 7. CEO REPORT

CEO Brengle provided the Board with updates on meetings he had attended, and upcoming events. CEO Brengle also announced that he would be retiring on July 4<sup>th</sup>, 2025. After some discussion a CEO Recruitment Committee was formed to consist of Director Hobin, and Pence. The Committee will work with CEO Brengle in creating a recruitment packet and presented it to the Board at the February Board Meeting for approval.

#### 8. VICE PRESIDENTS COMMENT

Vice President Pence welcomed new Board Member Adam Noah to the Board.

#### A. Board Elections

After some discussion it was moved by Director Hobin, seconded by Director Sherwood, and unanimously approved to elect Director Pence as President. Then Director Hobin moved to elect Director Noah as Vice President, Director Sherwood seconded the motion, and the motion unanimously passed for Director Noah as Vice President.
