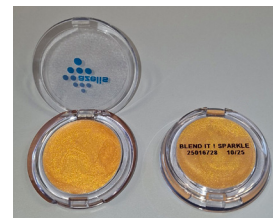

PROCEDURE

1. Premix phase B, using high speed mixing when adding the Aerosil 200.
2. Add phase B to phase A, mixing until dispersed. Heat to 80°C.
3. Add phase C to the batch, mixing until homogenous. Maintain temperature at 80°C.
4. Add phase D to the batch, mixing until homogenous.
5. Fill into suitable moulds or jars as desired. Allow to cool without mixing.
