

# Abyss Privacy Policy

**Effective Date: 26th September 2025**

The Abyss Protocol operates in a decentralized and permissionless manner on the Sui blockchain. Although we may collect and process information about users of the Abyss platform or interface in accordance with this Privacy Policy, we do not have information about all protocol users beyond what is already publicly available and recorded on the blockchain.

This Privacy Policy (the "Privacy Policy") explains how Abyss Labs ("we," "our," or "us") collects, uses, and shares information in connection with our Services as well as your rights and choices regarding such information in accordance with applicable data protection legislation, including the Data Protection Act (as amended) of the Cayman Islands (together, "Data Protection Legislation"). These terms apply to the Abyss platform, interface, and any other online location that links to this Privacy Policy (collectively, the "Services").

By using the Services, you also agree to our collection, use, and sharing of your information as described in this Privacy Policy. If you do not agree with the Terms of Use, you should not use or access the interface or the Services.

If you are an individual, this Privacy Policy will be relevant to you directly. If you are an entity or arrangement that provides us with personal data on individuals connected to you for any reason, this Privacy Policy will be relevant for those individuals and you should transmit this Privacy Policy to such individuals or otherwise advise them of its content.

## 1. Information Collection

### A. Information You Provide

We may collect the following information about you when you use the Services:

**Correspondence and Support:** When you contact us for support or other inquiries, you may share with us your contact details and contextual information relevant to your issue (such as wallet type, transaction details, device type, or error codes). This helps us respond and improve the Services.

**Platform Interactions:** When you interact with the Abyss platform and smart contracts, we may collect information about these transactions to provide services and improve platform performance.

You may choose to voluntarily provide other information to us that we have not solicited from you, and, in such instances, you are solely responsible for such information.

### B. Information Collected Automatically

We collect the following information:

**Wallet Address:** We may collect the wallet address you use to connect to the interface to block wallets that are associated with certain legally prohibited conduct. Separately, we may collect your wallet address as part of "Usage Information" to improve the interface and user experience of the Services.

**Transaction Data:** We collect information about your interactions with the Abyss platform and blockchain transactions to provide services and improve user experience.

**Device Information:** We may collect information about the device you use to access the interface, such as the device type, operating system, browser type, and screen dimensions. This information helps us optimize the interface for different devices and troubleshoot technical issues.

**Usage Information:** We may collect information about how you use the interface and Services, including your wallet address, access times, pages visited, features you interact with, links clicked, and search queries. This data helps us understand user behavior and continuously improve the platform.

## **2. Use of Information**

We may collect and use information for our legitimate business purposes in accordance with the practices described in this Privacy Policy, including where necessary for contract performance, compliance with legal obligations, or pursuant to our legitimate interests. Our business purposes include:

**Operating and Managing the Services:** To make the Services available to you and perform requested services, including facilitating blockchain transactions, providing customer support, sending technical notices and updates, and detecting fraud and security threats.

**Platform Improvement:** To continually improve the Services, optimize user experience, and fulfill legitimate business purposes as permitted under applicable laws.

We may use information that does not identify you (including aggregated or de-identified information) for any purpose except as prohibited by applicable law.

### **3. Sharing and Disclosure of Information**

We may share or disclose information in accordance with this Privacy Policy and for the purposes set out in the "Use of Information" section above. Categories of parties with whom we may share information include affiliates, professional advisors, service providers, and regulatory authorities.

We may share information that does not identify you (including aggregated or de-identified information) except as prohibited by applicable law.

### **4. Data Security**

We implement and maintain reasonable administrative, physical, and technical security safeguards to help protect information about you from loss, theft, misuse, unauthorized access, disclosure, alteration, and destruction. Nevertheless, transmission via the Internet is not completely secure and we cannot guarantee the security of information about you.

### **5. Your Rights**

You have certain data protection rights under Data Protection Legislation, including the right to access your personal data, stop direct marketing, restrict processing, have inaccurate data corrected, ask us to stop processing your data, and be informed of data breaches.

Note that we cannot edit or delete information stored on the Sui blockchain, including transaction data related to your wallet address and on-chain activities.
