- Case study and/or technical assessment: We'll ask you to outline a potential investment and
  why you think we should invest. You should be able to demonstrate your ability to interpret
  existing financial data and use it to make predictions. Don't worry too much if you don't have
  exact information, we're looking at your quality of thought.
- In-person interviews with a member of the team: If you are selected, you will be invited to participate in in-person interviews with a member of the team who will assess relative skills.
- Final round interview with each of the GPs: If you are a strong candidate, you will be invited
  to participate in a final round interview with the general partners of the firm. This will be an
  opportunity for you to learn more about the company's strategy and culture, and for the
  general partners to get to know you better.
