This transcript documents a high-risk co-parenting relationship built around a sustained pattern of coercive control — over information, over money, and over the children's access to Ryan. Two critical findings sit within that pattern: Ryan's methamphetamine use during contact, corroborated by a Family Court supervised-contact order, and a pattern of aggression that has led the twin daughters to fear him and refuse contact since early 2022. Beneath that, Ryan shows persistent financial control including a threat to withhold child support, sustained emotional abuse of Megan, and a repeated pattern of deflecting welfare concerns through counter-accusation. Ryan threatens to weaponise damaging information about Megan against the children, repeatedly attempts to bypass the Family Court parenting order by arranging contact directly with Tyler, dismisses the court order's legitimacy, and asserts he will contact the twins directly despite their expressed wishes — a pattern of undermining formal protective arrangements that recurs, in different forms, throughout the rest of this report and is treated here as the defining dynamic of the relationship.

COUNTER EVIDENCE

- Ryan's attempts to contact the children directly may reflect a genuine desire to maintain relationships with his children rather than a deliberate strategy to undermine the parenting order.
- A parent asserting their desire to communicate with their children is not inherently coercive, and the court order context means that what constitutes compliance is a legal question rather than purely a behavioural one.

AMBIGUITY NOTES

- The evidence for deliberate coercive control (as opposed to disengagement, avoidance, or genuine belief in parental alienation) is partially inferential for some of the supporting messages.
- The explicit threat to weaponise information is the anchor for this finding — without it, the remaining evidence would be more consistent with a disengaged or resistant co-parent than a coercive one.

SUMMARY OF BEHAVIOR

Ryan repeatedly fails to engage with Megan's communications about children's welfare, education, and medical needs across multiple years — including not responding to the formal drug-concern email, ignoring children's educational opportunities, and dismissing financial requests with contemptuous deflection — functioning as a second, quieter dimension of the same control pattern identified above: rather than acting on the children's access to him directly, Ryan withholds his own engagement as a form of leverage.

COUNTER EVIDENCE

- Ryan does engage substantively with some co-parenting communications throughout the transcript, particularly around contact scheduling, which suggests selective rather than total non-engagement.
- Megan's communication style is at times accusatory and lengthy, and Ryan's non-engagement may reflect communication avoidance rather than deliberate control.

AMBIGUITY NOTES

#3 • Child Welfare Concern

SUMMARY OF BEHAVIOR

Ryan's methamphetamine use poses a sustained and institutionally recognised risk to the children's safety during contact. Concerns are formally documented from mid-2020 and persist into early 2023, with a Family Court supervised contact order in place throughout as corroborating evidence of the risk.

COUNTER EVIDENCE

- Ryan consistently denies methamphetamine use throughout the transcript and at one point acknowledges addiction in the past tense, framing himself as in recovery.

SUMMARY OF BEHAVIOR

Ryan is reported to have shouted aggressively at the children on multiple occasions across the transcript period, causing the twin daughters to express fear of him and progressively refuse contact from early 2022 onward. The children's own expressed distress provides corroborating evidence beyond Megan's sole account.

COUNTER EVIDENCE

- Megan is the sole adult reporter of these incidents and may be characterising normal parental frustration or firm communication as aggression.

SUMMARY OF BEHAVIOR

Ryan explicitly threatens to stop paying child support as financial punishment, framing it as something that will "fix" Megan for asserting her position. This is immediately followed by targeted attacks on Megan's financial vulnerability and housing stability, constituting deliberate financial intimidation.

COUNTER EVIDENCE

- The threat occurs in the context of a heated exchange where Megan has made pointed accusations, and could be characterised as a reactive outburst rather than a premeditated intimidation strategy.
- Ryan does not follow through on the threat to stop paying in the messages that follow, which may indicate it was an expression of frustration rather than a genuine intention.

AMBIGUITY NOTES

- There is some overlap between this finding and the financial-control finding above — the distinction is that this finding focuses on the explicit threat framing as an intimidation tool.
- Whether the threat was carried out cannot be determined from the transcript alone.

COUNTER EVIDENCE

- Some of Ryan's dismissive responses may reflect genuine frustration with what he perceives as unfair accusations about his drug use and parenting rather than a deliberate pattern of emotional abuse.

AMBIGUITY NOTES

- The mutual nature of some exchanges makes it difficult to cleanly separate Ryan's demeaning behaviour from reactive responses to Megan's own pointed communications.
- The NPD accusation is noted as a particularly calculated attack but it is also possible Ryan genuinely believes this characterisation.

SUMMARY OF BEHAVIOR

Ivy is documented to have experienced escalating health and behavioural difficulties across the transcript period, including lactose intolerance, a school suspension following a physical altercation, and placement in counselling. Ryan's delay in funding Ivy's counselling adds a direct welfare dimension.

COUNTER EVIDENCE

- Children can experience health and behavioural difficulties for many reasons entirely unrelated to parental conflict.
- Requesting invoices for specific costs such as counselling fees is not inherently unreasonable as a financial accountability measure, even if the timing and pattern are concerning in context.

AMBIGUITY NOTES

- The stress-causation link between parental conflict and Ivy's behavioural difficulties is inferential and based on temporal correlation rather than direct evidence.
