



Legions Capital PPP Matrix

- Fixed percentage penalties must be no less than 3%.
- Declining penalty structures are permitted provided they do not exceed 5% and do not fall below 3% within the first three years.
- Examples: (5% / 4% / 3% / 3% / 3%) or (5% / 4% / 3% / 2% / 1%) or (5% / 4% / 3%) etc...
