Second amendment vide document No.55/B-IV/2021 dated 23-09-2021. Third amendment vide document No.89/IV/2022 dated 22-12-2022.

Now as per the Resolution Passed at the Extraordinary General Meeting held on 1st Feb 2025, where as due to mismanagement of the Chairman of the Trust **Sri. MACHA RAGHAVENDRA REDDY** including diversification of funds, forgery and breach of trust it is decided to cancel the amendments made vide document No. 89/IV/2022 dated 22-12-2022 and consider it as null and void because the same was executed on the basis of mis information and forgery.

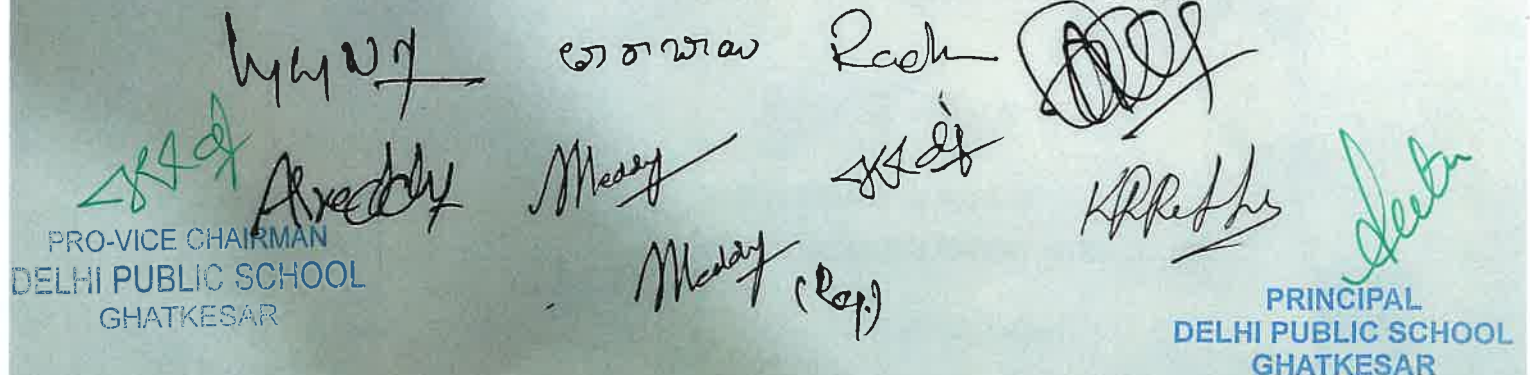
The Board of Trustees intends to remove Raghavendra Reddy Macha from the position of Chairman of Young India Educational trust based on the above following reasons.

- b. **TRUST PROPERTY**: The trust property shall be the corpus which was created originally plus the accumulated reserves and surplus including movable assets.

OBJECTS OF THE TRUST:

- i. To impart education, advancement, promotion and spread of education by establishing, maintaining, assisting and support of colleges, schools, educational institutions of pr-primary, primary, middle-school, high schools, junior college, graduation colleges, institutes both technical non-technical including engineering, medical etc irrespective of any caste, creed, religion sex etc and without profit motive.
- ii. To run, develop, improve any school, college, institution or to adopt, assist or help any existing educational institute with a motive to enhance education irrespective of any caste, creed, religion and sex.
- iii. To help the needy and economically backward students of all communities irrespective of any caste, creed, religion and gender for enhancing or providing their education.

- iv. To carry on all the activities including business for the purpose of fulfilling the above objectives.
- v. To carry on any charitable activity as provided in the Indian Income Tax Act, 1961.
- vi. To sever donate, gift, transfer its schools, institutes or operations to any trust or organization with similar objectives or a professional group including corporates for betterment of imparting of education.

TRUST MEMBERSHIP :

I) The term of their office is for life. Their position be that of a trustees with right to nominate either their legal successors or as their nominees.

That no trustee can be removed from the trust in whatsoever manner. However the Trustee has right to transfer his/her trust membership voluntarily by nominating his / her position in the trust to any other person, who is a major and eligible to enter a contract as per India Contract Act 1872, of his/her choice by sending a written intimation to General Secretary and with the consent of the management committee of the Trust.

II). In the absence of nomination or in the will or in case of sudden demise of the Trustee, his legal heir(s) shall be nominated as the trustees of the Trust in the place of the Trustee on recommendation of spouse of demised founder trustee to fill up the vacancy which shall be ratified at the succeeding meeting of the Founder Trustees.

IV). In the event of such legal heir(s) being a minor, he shall be represented by his guardian till such time he/she attains 18 years of age.

v) G. The right of nomination shall pass on the successor's nominee.
