- We never sell your personal information.

What Personal Information We Collect

- **Identification & Contact:** Name, email, phone, address, account details.
- **Profile & Lifestyle (optional):** Height, weight, sleep, nutrition, goals.
- **Health & Biomarker Data (with explicit consent):** Lab results, wearable data, physiological markers, AI-generated insights.
- **Device & Usage Data:** IP address, browser type, device information, browsing/app activity.
- **Transaction Data:** Membership, billing, shipping and payment details.
- **Marketing & Communications:** Preferences, survey responses, support communications..
- **Community & User Content:** Posts, ambassador content, challenge submissions.

How We Collect Information

We collect data directly from you (sign-up, purchases, uploads, support), automatically (cookies, analytics), and via partners (labs, wearables, professionals) with your consent.

Legal Bases for Processing (UK/EU)

We process personal data under the following lawful bases:

- **Contract:** to provide and manage your membership and core services.
- **Consent:** for processing health, biomarker, and wearable data, and for marketing communications.
- **Legal Obligation:** to comply with tax, accounting, and regulatory requirements.
- **Legitimate Interests:** to improve and secure our services, analyze usage, and communicate relevant updates (unless overridden by your rights).

We process health-related and biometric data only under Article 9(2)(a) of the GDPR – with your explicit consent, which you may withdraw at any time by contacting privacy@axolongevity.co

How We Use Your Information

- Deliver and manage our core services (biomarker tracking, dashboards, coaching).
- Personalise insights and recommendations.
- Process payments and administer memberships.
- Improve, test, and secure our products and platform.
- Communicate with you (support, service updates, marketing with consent).
- Comply with legal, regulatory or contractual obligations.

How We Share Information

We do not sell personal data. We may share your information only with:

- Accredited labs (for biomarker processing)
- Service providers (e.g. payments, hosting, analytics)
- Professionals or partners you choose to connect with (e.g. medical)
- Affiliates/subsidiaries for internal operations.
- Regulators or authorities where required by law.

All third parties are bound by confidentiality and data protection agreements.

Data Retention

We retain data only as long as necessary for the purposes outlined above or as required by law:

- Account data: for the life of your account + up to 5 years.
- Biomarker/health data: for the membership period + up to 5 years (unless withdrawn sooner)
- Transaction data: 7–10 years (for tax/legal compliance).

- Logs and analytics: 12–24 months.
- Anonymized/aggregated data: may be kept indefinitely.

Sensitive Information

We only process health-related data with your explicit consent and do not collect other sensitive categories (race, religion, political views) unless required by law.
