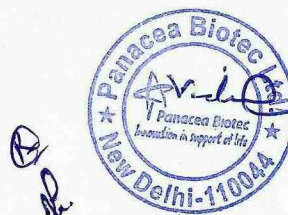

As on 30.09.2024, Mr. Sandeep Jain actually owns 95,39,891 equity shares (15.58%) and total promoters and promoters' group shareholding is 4,45,82,157 (72.79%). The actual total public shareholding as on 30.09.2024 is thus 1,66,68,589 (27.21%) to the total equity share capital.

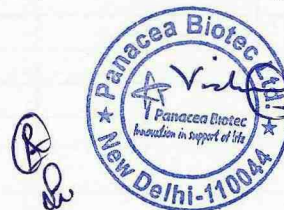
