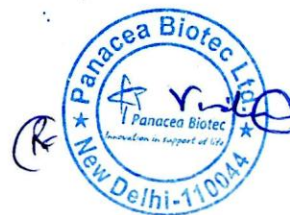

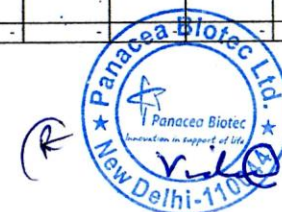

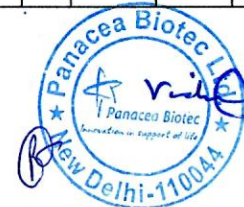


Table IV - Statement showing shareholding pattern of the Non Promoter- Non Public Shareholder

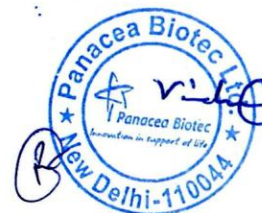
