

LETTER OF REAPPOINTMENT AND CONTINUATION FOR INDEPENDENT DIRECTOR

I am writing to confirm our decision to reappoint and continue you on the Board of Standard Glass Lining Technology Limited ('the Company') with effect from July 22, 2024, for a period of 5 (Five Years) Tenure. This letter of reappointment sets out the terms and conditions covering your reappointment which are as follows:

1. REAPPOINTMENT

- a. You are reappointed and will continue as a Non-Executive Independent Director on the Board of Standard Glass Lining Technology Limited with effect from July 20, 2024, pursuant to the approval of the Shareholders in their Meeting held on July 22, 2024. Your appointment is subject to the maximum permissible Directorships that one can hold as per the provisions of the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015.
- b. The term Independent Director should be construed as defined under the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015.
- c. The Company has adopted the provisions with respect to reappointment, continuation and tenure of Independent Directors which are consistent with the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015. Accordingly, the Independent Directors will serve for not more than two terms of five years each on the Board of the Company. The Company is at liberty to disengage Non-Executive Independent Director earlier subject to compliance of relevant provision of Companies Act, 2013.

2. COMMITTEES

The Board of Directors (the Board) may, if it deems fit, invite you to be reappointed to one or more existing Board Committees or any such Committee that is set up in the future. Your reappointment on such Committee(s) will be subject to the applicable regulations.

3. TIME COMMITMENT

- a. As a non-executive Director, you are expected to bring objectivity and independence of view to the Board's discussions and to help provide the Board with effective leadership in relation to the Company's strategy, performance, and risk management as well as ensuring high standards of financial probity and corporate governance. The Board meets at least four times a year. The Audit Committee also meets at least four times in a year. Besides, there are other Committee meetings like Nomination and

Remuneration Committee, and Corporate Social Responsibility Committee meetings which are ordinarily convened twice in a year. You will be expected to attend Board, Board Committees to which you may be appointed and Shareholders meetings and to devote such time to your duties, as appropriate for you to discharge your duties effectively.

- b. By accepting this reappointment, you confirm that you are able to allocate sufficient time to meet the expectations from your role to the satisfaction of the Board.

4. ROLE AND DUTIES

- a. Your role and duties will be those normally required of a Non-Executive Independent Director under the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015. There are certain duties prescribed for all Directors, both Executive and Non-Executive, which are fiduciary in nature and are as under:
 - b. You shall act in accordance with the Company's Articles of Association.
 - c. You shall act in good faith in order to promote the objects of the Company for the benefit of its members as a whole, and in the best interest of the Company.
 - d. You shall discharge your duties with due and reasonable care, skill and diligence.
 - e. You shall not involve yourself in a situation in which you may have a direct or indirect interest that conflicts, or possibly may conflict, with the interest of the Company. Please refer to clause 6 for full explanation on conflict of interest.
 - f. You shall not achieve or attempt to achieve any undue gain or advantage either to yourself or to your relatives, partners or associates.
 - g. You shall not assign your office as Director and any assignments so made shall be void.
 - h. You shall act in compliance and abide with the Code of Conduct for Independent Directors as prescribed in Schedule IV of the Companies Act, 2013.

In addition to the above requirements applicable to all Directors, the role of the Non-Executive Director has the following key elements:

Strategy: Non-Executive Directors should constructively challenge and help develop proposals on strategy;

Performance: Non-Executive Directors should scrutinize the performance of management in meeting agreed goals and objectives;

Risk: Non-Executive Directors should satisfy themselves on the integrity of financial information and that financial controls and systems of risk management are robust and defensible;

People: Non-Executive Directors are responsible for determining appropriate levels of remuneration of Executive Directors and have a prime role in appointing, and where necessary, removing Executive Directors and in succession planning.

Reporting: Non-Executive Directors take responsibility for the processes for accurately reporting on performance and the financial position of the Company; and

Compliance: Non-Executive Directors should keep governance and compliance with the applicable legislation and regulations under review and the conformity of the Company's practices to accepted norms.

5. STATUS OF APPOINTMENT

- a. You will not be an employee of the Company, and this letter shall not constitute a contract of employment. You will be paid such remuneration by way of setting fees for meetings of the Board and its Committees as may be decided by the Board and approved by the Shareholders from time to time. Further, you will also be paid remuneration by way of commission as may be approved by the Board and the Shareholders from time to time.
- b. The Company has finalized the sitting fee to be paid to the Non-Executive Directors for attending Board Meetings. The Directors are entitled for reimbursement of actual out of pocket expenses incurred towards attending the meetings upon production of relevant bills.

6. CONFLICT OF INTEREST

- a. It is accepted and acknowledged that you may have business interests other than those of the Company. As a condition to your reappointment commencing, you are required to declare any such directorships, appointments and interests to the Board in writing in the prescribed form at the time of your reappointment and at such times as are required.
- b. In the event that your circumstances seem likely to change and might give rise to a conflict of interest or, when applicable, circumstances that might lead the Board to revise its judgment that you are independent, this should be disclosed to both the Chairman and the Secretary.

7. CONFIDENTIALITY


- a. All information acquired during your appointment is confidential to the Company and should not be released, either during your appointment or following termination (by whatever means) to third parties without prior clearance from the Chairman unless required by law or by the rules of any stock exchange or regulatory body. On reasonable request, you shall surrender any documents and other materials made available to you by the Company.
- b. Your attention is also drawn to the requirements under the applicable regulations and the Code of Conduct for Directors and Senior Managerial Personnel which concern the disclosure of price sensitive information and dealing in the securities of the Company. Consequently, you should avoid making any statements or performing any transactions that might risk a breach of these requirements without prior clearance from the Chairman or the Secretary.

8. INDUCTION

Immediately after your reappointment, you will be invited to attend an initial induction session and, thereafter, ongoing training and familiarization sessions, including briefings from management and site visits. Please avail yourself of these opportunities as fully as is appropriate to your personal circumstances.

9. EVALUATION

The Company has adopted a policy on Board Evaluation. The policy provides for evaluation of the Board, the Committees of the Board and individual Directors, including the Chairman of the Board. As per the Policy, the Company will carry out an evaluation of the performance of the Board as a whole, Board Committees and Directors on an annual basis. Your appointment and appointment on the Board shall be subject to the outcome of the yearly evaluation process.

10. INSURANCE

The Company has Directors' and Officers' liability insurance, and it is intended that the Company will assume and maintain such cover for the full term of your appointment.

11. INDEPENDENT PROFESSIONAL ADVICE

There may be occasions when you consider that you need professional advice in furtherance of your duties as a director and it will be appropriate for you to consult independent advisers at the Company's expense. The Company will reimburse the full cost of expenditure incurred in accordance with the Company's policy.

12. DISCLOSURE OF INTEREST

The Company must include in its Annual Accounts a note of any material interest that a director may have in any transaction or arrangement that the Company has entered into. Such interest should be disclosed no later than when the transaction or arrangement comes up at a Board meeting so that the minutes may record your interest appropriately and our records are updated. General notice that you are interested in any contracts with a particular person, firm or company is acceptable.

13. TERMINATION

- You may resign from your position at any time, and should you wish to do so, you are requested to serve a reasonable written notice on the Board.
- Continuation of your reappointment is contingent on your getting re-elected by the shareholders in accordance with provisions of Companies Act, 2013 and the Articles of Association of the Company, from time to time in force. You will not be entitled to compensation if the shareholders do not re-elect you at any time.
- Your reappointment may also be terminated in accordance with the provisions of the Companies Act, 2013 and Articles of Association of the Company from time to time in force.

14. GOVERNING LAW:

This agreement is governed by and will be interpreted in accordance with Indian Law and your engagement shall be subject to the jurisdiction of the Indian Courts.

If you are willing to accept these terms of appointment relating to your reappointment as a Non - Executive Independent Director of the Company, kindly confirm your acceptance of these terms by signing and returning to us the enclosed copy of this letter.
