

# OUR VISION IS TO BE THE CRUSHING AND SCREENING CONTRACTOR OF CHOICE


At Crushing Services Australia, we provide tailored crushing and screening solutions for mining and civil projects, with a focus on safety, innovation, and efficiency.

# OUR PROJECTS



## CROSS-ISLAND TRENCHING PROJECT

Operating within one of Australia's most environmentally sensitive zones, CSA is supporting the Barrow Island Cross-Island Trenching project with specialised crushing and screening services. The project is a complex operation carried out within a highly regulated Class-A nature reserve which requires strict bio-security compliance, with stringent quarantine controls to protect the island's fragile ecosystem. CSA deployed specialised equipment and tailored operational procedures to meet these

environmental requirements while maintaining high productivity. Since October 2023, CSA has kept a record of zero injuries, highlighting our strong safety culture. With the project on track for completion in 2025, our commitment to exceeding the highest environmental and safety standards reinforces our reputation as a reliable partner, driven by integrity, innovation, and a focus on achieving the best possible outcomes for our clients and the communities we serve.

## BLUE HILLS OPERATION PROJECT

CSA is a key partner in KMG's Blue Hills operation, providing crushing and screening services for high-grade direct shipping ore (DSO). Since commencing operations, CSA has processed over 3 million tonnes of DSO, consistently achieving a daily throughput of 4,500 tonnes. Given the tight shipping schedules and high demand for precision in material

handling, CSA implemented a rigorous maintenance program. This program ensures maximum plant uptime and reliability. With over 40,000 man-hours worked and zero injuries recorded, CSA has maintained a strong safety culture while playing a crucial role in supporting KMG's production goals for 2025 and beyond.

## PERDAMAN CERES UREA PLANT PROJECT

CSA continues to deliver crushing and screening services for the Perdaman Ceres Urea Plant project—a significant development supporting Australia’s fertiliser industry. The project involves two high-capacity crushing plants supplying critical construction materials. Located near significant Aboriginal rock art, the site demanded strict environmental and heritage protection. Being awarded this work reflects CSA’s strong commitment

to cultural and environmental responsibility. A custom dust suppression system was implemented to minimise environmental impact while maintaining a consistent 5,000 tonne daily throughput. With over 100,000 man-hours and zero injuries under our Life-Saving Rules framework, CSA is on track to exceed 2.5 million tonnes and complete the project safely, on time, and to the highest standard.



## WOODSIDE PLUTO TRAIN 2 PROJECT

CSA provided crushing and screening services for the expansion of the Pluto Train 2 LNG facility, a key infrastructure project at one of Australia’s leading gas plants. The project involved processing 400,000 tonnes of raw materials to support site preparation and foundation works while adhering to strict safety and environmental regulations. Operating in a high-risk environment, CSA employed advanced dust suppression and noise mitigation strategies to

minimise disruption. The project was completed on schedule, with CSA’s skilled workforce and high-performing equipment ensuring seamless execution. CSA’s successful contribution was crucial to Woodside’s infrastructure expansion, further reinforcing our reputation for delivering quality and efficiency in demanding conditions.
