Mobile Classes - Airborne Complete Policies

AIRBORNE GYMNASTICS CLUB USA, LLC

Mobile Gym Classes Policy Agreement

For gymnastics enrichment classes held at schools, recreation centers, and partner locations

Key Parent Commitments

- Mobile class tuition is paid once at registration for the semester or program term.
- There is no monthly continuous billing for mobile semester classes unless a specific program states otherwise.
- Classes are held in spaces assigned by the host site, and Airborne brings, sets up, and removes gymnastics equipment for each class.
- Missed classes are not refunded, and make-ups are not guaranteed.

Program Description & Host Location

- Airborne brings portable gymnastics equipment to a school, recreation center, or partner location and conducts class in a classroom, cafeteria, gym, multipurpose room, outdoor area, or other space directed by the site administrator.
- Airborne will set up equipment before class and remove equipment after class. Parents understand the host location controls the space, access rules, parking, building procedures, and many site conditions.
- Parents and students must follow all Airborne rules and all host-site rules, including check-in, pick-up, building access, and safety procedures.

Semester Enrollment, Tuition & Payment

- Parents register and pay once at the beginning of the semester or program term. Payment is due at the time of registration unless Airborne states otherwise in writing.
- There is no continuous monthly billing for mobile semester classes. Enrollment covers only the selected semester, session, or program term.
- Families enrolled in the current semester may receive early enrollment access for the next semester, subject to availability and published deadlines.
- Registration fees, tuition, and any program fees are non-refundable unless Airborne cancels the entire program and does not offer a reasonable reschedule, credit, or alternative.

Attendance, Absences & Site Closures

- Tuition is not prorated or refunded for student absences, illness, vacation, schedule conflicts, or early withdrawal after the program begins.

- Because mobile classes depend on host-site schedules and space availability, make-up classes are not guaranteed.
- If a host site closes or cancels access due to weather, school events, holidays, safety concerns, building issues, or administrative decisions, Airborne may attempt to reschedule when feasible. If rescheduling is not feasible, no refund is guaranteed unless required by law or specifically offered by Airborne.

Drop-Off, Pick-Up & Supervision

- Parents are responsible for following the host site's drop-off and pick-up procedures.
- Children must be picked up promptly at the end of class unless they are otherwise enrolled in the host site's school, afterschool, or recreation program.
- Airborne is responsible for instruction during the scheduled class time only and is not a licensed child care provider.

Program Is Not Licensed Child Care

I acknowledge that Airborne's mobile gymnastics enrichment program is not a licensed child care facility. I understand the program is not required to be licensed by the Georgia Department of Early Care and Learning and is exempt from state licensure requirements.

Assumption of Risk, Waiver & Release of Liability

I understand that gymnastics, fitness activities, camps, games, parties, and related recreational activities involve inherent risks. These risks include, but are not limited to, falls, collisions, impact with equipment or other participants, muscle strains, sprains, broken bones, head, neck, back, or spinal injuries, emotional distress, serious injury, paralysis, or death.

I voluntarily choose to allow my child to participate and assume all known and unknown risks related to participation, use of equipment, use of the facility or program space, and participation in any related activities.

To the fullest extent permitted by law, I release, waive, and discharge Airborne Gymnastics Club USA, LLC, Kamilah Jones-Norman, its owners, officers, employees, contractors, volunteers, affiliates, host locations, and program partners from claims, demands, damages, or liabilities arising out of ordinary negligence or risks associated with participation in Airborne programs.

I understand this release does not waive rights that cannot legally be waived, including claims based on gross negligence, willful or wanton misconduct, intentional misconduct, or criminal conduct where such waiver is not permitted by law.

I agree to indemnify and hold harmless the Airborne Parties from claims, costs, damages, and attorney fees arising out of my child's participation, conduct, failure to follow rules, or my own actions or omissions.

Medical Authorization

In the event of illness, injury, or emergency, I authorize Airborne staff to provide basic first aid, contact emergency services, and/or arrange transportation to the nearest appropriate medical facility when reasonably necessary.

I understand Airborne does not provide medical or health insurance for participants. I am financially responsible for all medical treatment, transportation, deductibles, co-pays, and related expenses. I authorize any insurance benefits to be paid directly to the treating provider, when applicable.

I authorize Airborne and its insurance representatives to release or obtain information reasonably necessary for treatment, incident reporting, or claim processing.

Health, Illness & Communicable Disease

I agree not to bring my child to class, camp, or an event if the child is sick, has a fever, has symptoms of a contagious illness, or has been instructed to isolate or stay home. I understand group activities carry risk of exposure to illnesses, including flu, COVID-19, and other communicable diseases, and I assume those risks to the fullest extent permitted by law.

Media Release

I grant Airborne permission to photograph, video record, or otherwise capture images of my child during classes, camps, events, and activities, and to use those images for lawful business purposes, including marketing, social media, website content, and promotional materials, without additional notice or compensation.

If I prefer to restrict media use for my child, I understand I must provide written notice to Airborne before participation begins. Airborne will make reasonable efforts to honor written media restrictions but cannot guarantee exclusion from all group or background images.
