## Dear HHA Landlord:

Effective January 1, 2015, Houston Housing Authority (HHA) will begin to conduct your Housing Quality Standards (HQS) *annual* inspections biennially (once every two years), for *most* Housing Choice Voucher (HCV) assisted units. Initial or Special inspections will be conducted as required; there will be no change to these inspection types.

Assisted units requiring annual inspections located in the Northwest and Southwest zones of HHAs service areas of jurisdiction will be inspected in 2015 and in odd numbered years going forward. Assisted units requiring annual inspections located in the Northeast and Southeast zones of Houston and the surrounding areas will be inspected in 2016 and in even numbered years going forward. This means your unit will be inspected, at a minimum, every other year. HHA will continue to conduct inspections for units receiving assistance through the Mod-Rehab program and/or Project Based Voucher (PBV) program annually.

On June 25, 2014 HUD published a notice of statutory changes entitled "HUD Implementation of Fiscal Year 2014 Appropriations Provisions on Public Housing Agency Consortia, Biennial Inspections, Extremely Low-Income Definition, and Utility Allowances," in the Federal Register. The 2014 Appropriations Act included statutory changes that "are designed to reduce administrative burdens on PHAs, enable PHAs to better target assistance to families in need of such assistance, and reduce Federal costs." Section 220 of the 2014 Appropriations Act allows housing authorities to comply with inspection requirements by inspecting units **not less than biennially**. The provision was immediately effective for any unit under Housing Assistance Payment (HAP) contract where the housing authority has conducted a Housing Quality Standards (HQS) inspection within 12 months preceding July 1, 2014. HHA opted to implement the change effective January 1, 2015.

## Frequently Asked Questions (FAQs)

1. How will I know what year my unit will be inspected?

**HHA will continue to provide reasonable notice of inspection via written or oral communication? If your unit is inspected in 2015, you should not expect another inspection until 2017 unless a 'Special' (Emergency, Complaint and/or Quality Assurance) inspection is scheduled.**

2. What if my unit is not scheduled for inspection during a year, but I want to report a HQS issue?

**The owner, tenant, and/or third party may continue to report potential HQS violations to request an emergency and/or complaint inspection as needed.**

3. Are all units subject to the biennial inspection?

**No. HHA will continue to inspect Mod-Rehab and PBV units every year (annually).**

4. Is it possible that my unit will be inspected within a short time frame from the last Annual inspection?  
**Yes. Due to HHA beginning to conduct some inspections biennially your unit may be scheduled for inspection again. For example; your unit passed the Annual inspection in October 2014, but it is scheduled again for inspection in January 2015 because it is located in an odd year inspection zone.**

**HHA Zip Codes Based Upon Zones:**

*Northeast and Southeast will be inspected in 2016 (Even Year Inspections).*

***Mod-Rehab and PBV units will be inspected annually.***
