Majesta Learning Ltd ("we," "us," "our"), company number: 16639923, uses cookies and similar technologies on our website [www.majestalearning.com](http://www.majestalearning.com) (the "Website"). ### 2. WHAT ARE COOKIES?

Cookies are small text files that are placed on your device (computer, smartphone, tablet) when you visit a website. They are widely used to make websites work more efficiently and to provide information to website owners.

- **Session Cookies:** Temporary cookies that expire when you close your browser
- **Persistent Cookies:** Remain on your device for a set period or until you delete them

##### 2.2 By Origin

- **First-Party Cookies:** Set directly by our website

### 3. HOW WE USE COOKIES

#### 3.1 Strictly Necessary Cookies

These cookies are essential for the website to function properly and cannot be switched off in our systems.

##### Purpose:

- Enable core website functionality
- Maintain website security and performance
- Support basic website operations

**Legal Basis:** Legitimate interest (essential for service provision)

##### Examples:

- Session management cookies
- Security cookies
- Load balancing cookies

### 4. OUR COOKIE USAGE

#### 4.1 Strictly Necessary Cookies

We only use strictly necessary cookies that are essential for our website to function properly. These cookies enable core website functionality including session management, security, and basic site operations.

**Note:** Since our website is built on Webflow and we have not implemented any third-party tracking services, analytics tools, or marketing integrations, we only use strictly necessary cookies required for basic website functionality.

## 5. YOUR COOKIE CHOICES

### 5.1 Cookie Consent

Since we only use strictly necessary cookies that are essential for website functionality, no cookie consent banner is required. These cookies are automatically set based on legitimate interest for service provision.

### 5.2 Browser Settings

Most browsers allow you to:

- Block cookies from specific sites
- Delete existing cookies
- Set preferences for future cookies
