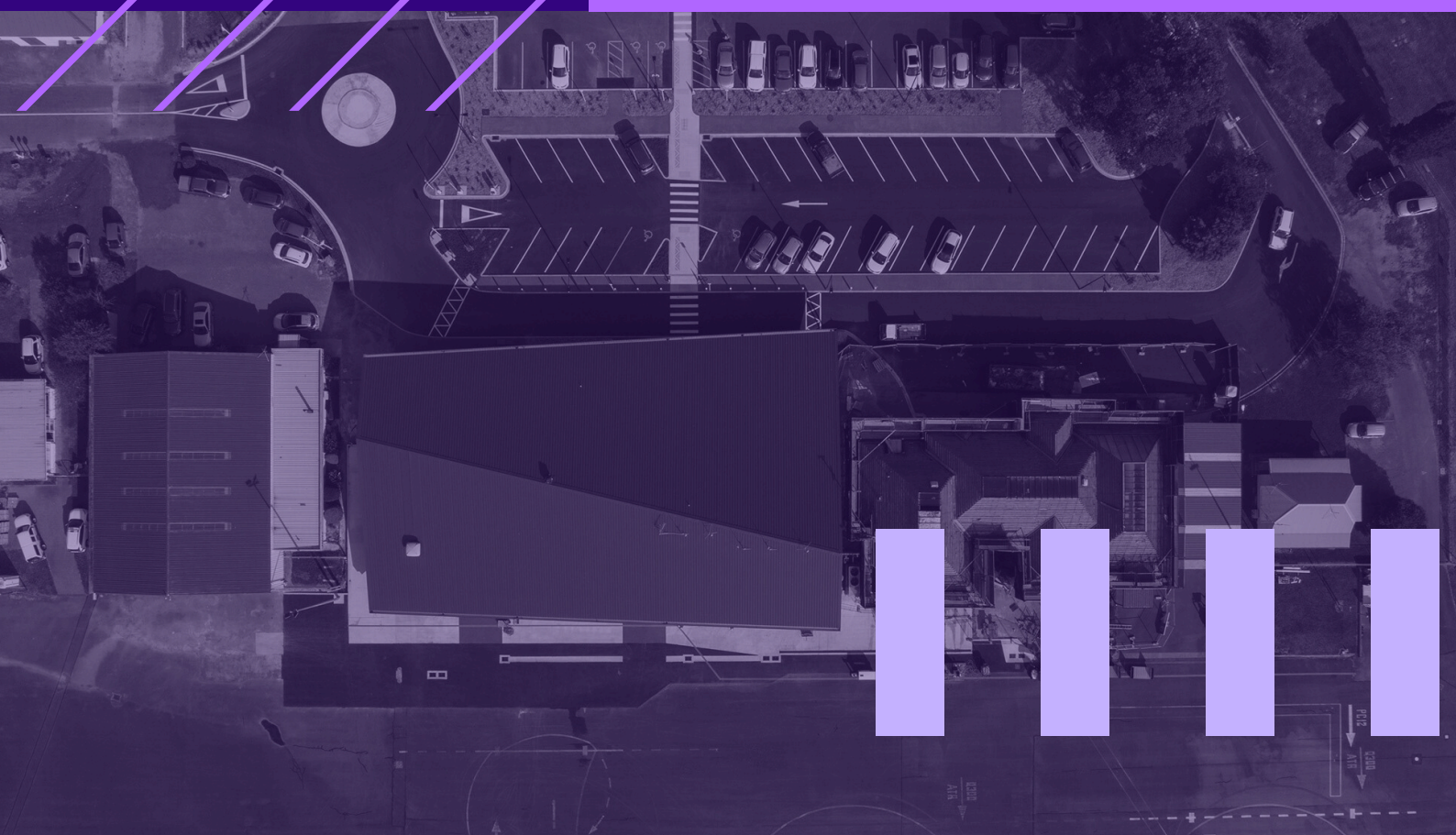
The Story

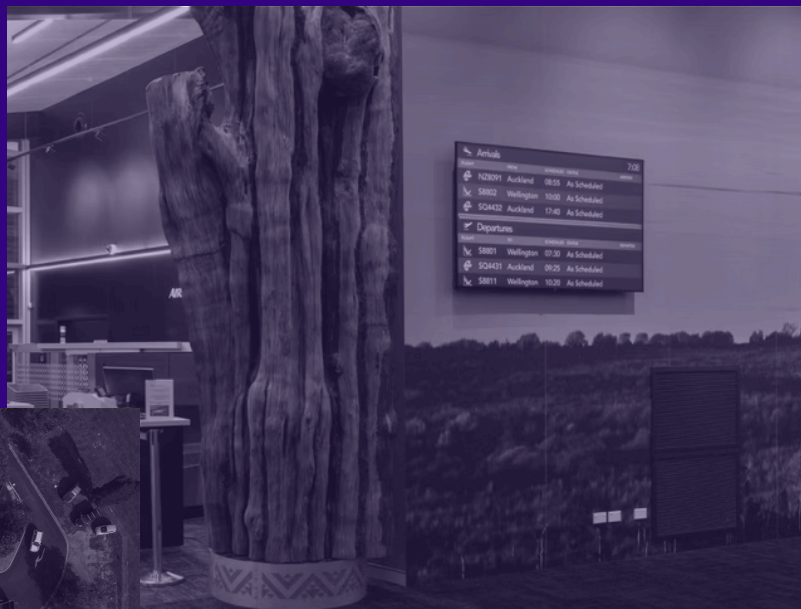
Taupo Airport, located near the picturesque Lake Taupo in New Zealand, serves as a key aviation hub for the region. The airport, jointly managed by Taupo District Council and the Ministry of Transport representing the Crown, is committed to maintaining the highest standards of safety and compliance.

Taupo Airport set out to modernise how it manages safety and compliance. The airport needed a platform designed for aviation - capable of staying in lockstep with changing CAA requirements while simplifying day-to-day work for a small, busy team.

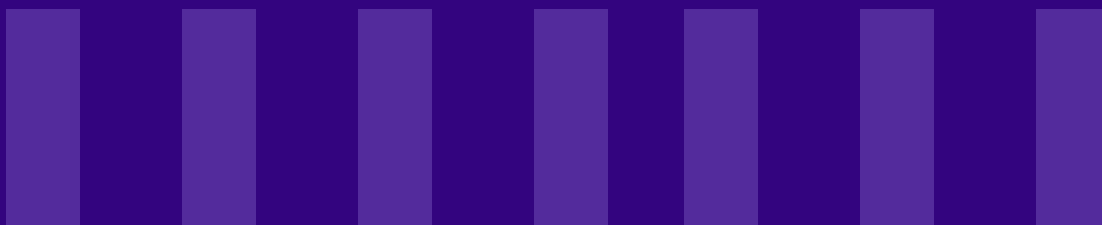




The Challenge

Taupo Airport was encountering a range of operational inefficiencies and compliance challenges:

- **Outgrown, non-aviation system**
An adapted legacy tool couldn't keep pace with regulatory change
- **Manual, fragmented processes**
Aerodrome inspections, contractor inductions, and other tasks relied on paper, spreadsheets, and email - slow and error prone.
- **Audit and reporting friction**
Proving compliance and preparing materials for leadership took extra effort



Why OneReg

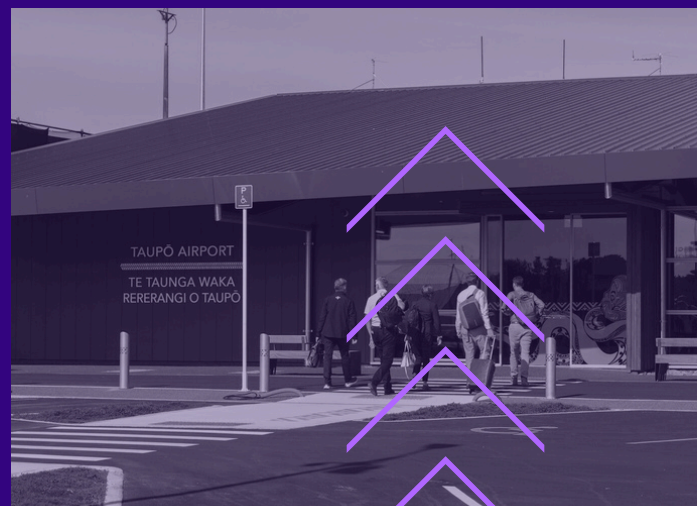
Smart notifications and integrated data entry replaced scanning and manual re-keying

Since implementing OneReg, Taupo Airport has experienced several significant benefits. The system's ability to integrate new modules and audits has streamlined regulatory adherence.

OneReg configured Runway Surface Condition reporting to meet the latest CAA expectations, stood up pre-built templates and managed the switch-over to minimise disruption, and moved contractor inductions and occurrence reporting from paper to digital workflows with automatic notifications.
