

USER AGREEMENT

of the website payinrussia.com

1. General Provisions

1.1. This document is an official offer from the Administration of the website payinrussia.com (hereinafter referred to as the Website) to enter into a user agreement (hereinafter referred to as the Agreement), which establishes the rules for using all materials and services available on the Website.

1.2. Service is a set of programs and technical means that you can use on the Website. It includes everything necessary for the proper functioning of the Website: interface, programs, tools, and algorithms.

1.3. Website Administration is the PayInRussia service, which owns all rights to the Website and manages it.

1.4. User is an individual with legal capacity in accordance with applicable law, who agrees to the terms of the Agreement and uses the Website.

1.5. The Agreement is considered concluded from the moment you start using the Website or its individual functions. You do not need to sign this document; it is valid in electronic form.

1.6. By using the Website, you confirm that you are a User and fully accept all terms of the Agreement without any exceptions.

If you do not agree to these terms, you must immediately stop using the Website and leave it.

2. Your Personal Data

2.1. If using any services on the Website requires entering your personal data, it will be stored and processed in accordance with the legislation of the Russian Federation on personal data (Federal Law No. 152-FZ of July 27, 2006).

2.2. Your personal data will remain confidential. The exception is cases where you yourself decide to make this information publicly available.

2.3. The Website does not transfer your personal data to third parties, except in cases provided for by the law of the Russian Federation.

2.4. The Website Administration takes all necessary measures to protect your personal data.

3. User Responsibilities

3.1. The User undertakes to refrain from any actions that may be regarded as a violation of the legislation of the Russian Federation or international legal norms. This includes, but is not limited to, violations in the field of intellectual property, copyright and related rights, as well as generally accepted ethical and moral principles. In addition, the User must not commit actions that may disrupt or lead to the disruption of the stable operation of the Services and the Website as a whole.

3.2. The use of any materials posted on the Website without the prior permission of the copyright holder is strictly prohibited.

3.3. When quoting any materials from the Website, including those protected by copyright, the User is obliged to provide a link to the Website as the source.

3.4. The Website Administration is not responsible for the consequences of the User visiting or using third-party Internet resources, links to which may be posted on the Website.

3.5. The Website Administration does not assume responsibility and has no direct or indirect obligations to the User for any potential or actually incurred losses. This applies to losses associated with any content of the Website, available on it, or obtained through external sites, resources, as well as any other User interactions arising from the use of information or links to third-party resources posted on the Website.

4. Additional Provisions

4.1. This Agreement enters into force from the moment it is published on the Website and applies to all information posted on the Website on the Internet.

4.2. All possible disagreements arising from this Agreement or related to it will be resolved in accordance with the current legislation of the Russian Federation.

4.3. If the Website Administration does not take immediate action in the event of a User's violation of the terms of the Agreement, this does not deprive the Administration of the right to take necessary measures in the future to protect its interests and copyrights to the Website materials protected by law.

4.4. The Website Administration reserves the right to unilaterally make changes to the terms of this Agreement at any time. These changes come into force from the moment the new version of the user agreement is published on the Website. If the User does not agree with the changes made, he is obliged to immediately leave the Website and stop using its materials and Services.
