#### Superintendent McGuire started the meeting.

- **Reports**

- Pamela Rodriguez: Reported on DC 37's new member orientation for new hires on November 7th, site meetings with principals, and hiring calls for school lunch helpers.
- Craig Slutzkin: Discussed the recent CEC meeting, the presentation by the Office of Food and Nutrition, and plans for workshops on the Wit & Wisdom curriculum.
- Jung Min Lee: Provided updates from the Manhattan High Schools President's Council, including college fairs, the use of Naviance for college and career readiness, and the transformation of their high school.
- Jessica Harvey: Reported on the chapter leader training and the upcoming tenure celebration for teachers.

- **Bylaws Review**
