NEWS UPDATES

1. Four measures to be applied to foreign tourists, including those from China

Thailand's Public Health Ministry has adopted four measures to be applied to all tourists visiting Thailand, including those from China after the Chinese Government eases travel restrictions on their citizens on January 8th

The measures are:

1. All visitors must have received at least two doses of COVID-19 vaccine before their arrival
2. All visitors should take out health insurance coverage, which includes COVID-19, before their departure for Thailand
3. All visitors should wear face masks while travelling on public transport in Thailand and in public places and take rapid antigen tests if they develop COVID-like symptoms.
4. Visitors should postpone their visits to Thailand if they develop a respiratory disease.

The measures were proposed by a technical sub-committee of the National Communicable Disease Committee and were approved on January 5th.

2. First Tourism Flight from China to Arrive in Thailand on January 9th

- The Minister of Tourism and Sports, Mr. Phiphat Ratchakitprakarn, stated to the press, "The first flight from China is from Xiamen Airlines which is a direct flight from Xiamen to Suvarnabhumi Airport and will be full with **200 passengers** who will arrive on January 9th."
- Mr. Suttipong Kongpool, the director of the Civil Aviation Authority of Thailand said, "There will be up to 20 flights per day from China in the first three months of this year arriving at Suvarnabhumi International Airport, Phuket International Airport and Chiang Mai International Airport. Each flight will contain about 200 passengers which will be about 4,000 passengers per day."

3. Chinese torrent unlikely this month

- An influx of Chinese tourists is unlikely during the coming Lunar New Year holiday as not enough flights can be added in such a short time, while large tour groups are still awaiting an official announcement from the Chinese government, according to the Association of Thai Travel Agents (Atta)
- TAT will launch a campaign welcoming Chinese tourist, as many of them are set to celebrate Chinese New Year in Phuket. TAT said **Phuket welcomed 208,750 tourists from Dec 30-Jan 2, 2023**
- Public Health Minister Anutin Chanvirakul reminded while visitors arriving from China won't be treated differently from travellers from other countries, they must be fully vaccinated against Covid-19 and hold an appropriate health insurance policy.

4. Phuket expects to welcome 12 million domestic and foreign tourists this year, marking an 85% recovery from 14 million visitors in 2019

- Of the 12 million travellers expected to visit Phuket in 2023, 8 million will be foreigners and 4 million from within the country," the association's chairman Sueksit Suwanditthakul said.
- He said the occupancy rate of hotels in Phuket is expected to be 80% from January to February before declining to 70% in March," he said.

5. Tourism Authority of Thailand recommends booster vaccination booster for workers

- The Tourism Authority of Thailand (TAT) is advising company owners to ensure that their employees have received a booster dose of the COVID-19 vaccine to prepare for the return of Chinese tourists.
- All tourism industry employees, particularly those who have close contact with tourists, such as hotel receptionists, drivers and tour guides, should receive a booster vaccination to prevent infection.

COVID19 Update

International passengers travelling from China, Hong Kong, Japan, South Korea, Singapore and Thailand to India to undergo mandatory RTPCR tests before departure and upload report on Air Suvidha portal from 1st January 2023

This is in addition to Random 2% tests of all International Passengers on their arrival to India

New Delhi, 29th Dec 2022

International passengers travelling from China, Hong Kong, Japan, South Korea, Singapore and Thailand to India will be mandatorily required to undergo RTPCR tests before their departure from these countries/destinations and upload the COVID negative RTPCR test report on Air Suvidha portal from 1st January 2023. The test should have been conducted within 72 hours of undertaking the journey to India.

This requirement is in addition to the random 2% tests of all international passengers in all incoming international flights on their arrival to India irrespective of port of departure.

This is being done in view of the evolving COVID19 situation across the world, particularly in the aforesaid countries.

India has asked that 6 countries need to submit RT PCR before arriving in India. so from 1st of Jan all airlines are checking RTPCR test results for all Indian flights from Thailand to India. This is now mandatory.




