

Phuket latest measurements:
Additional measures of entering Phuket

New Stringent Measures
will be intensified for
entering Phuket!
during 21-30 April, 2021.

- 1. **Eligible** to travel to Phuket for those who are fully vaccinated with official documents,
- 2. **Eligible** to travel to Phuket for those who have got Covid-19 free certificate (no more than 72 hours before departure),
- 3. Those who do not have documents listed No. 1 and 2, a **300-baht Rapid Antigen Test upon arrival is required,**

Remarks:

- Air transportation channel : everyone is requested to have covid-19 tested upon arrival at the Phuket Airport.
- Land transportation channel: from those 17 red-zoned provinces, are requested to have covid-19 tested at the Phuket Checkpoint.

- 4. The "**MorChana**" Application is obligated to download, and all travelers have to register themselves in www.gophuket.com. Also, reporting oneself at subdistricts' **Center of Emergency (EOC)** is highly suggested (for the ease of tracing)

Exception
Those who work for goods transportation and do not stay overnight in Phuket, together with a document of permission, are eligible to enter to Phuket.

**** 17 provinces are:

1. Bangkok, 2. Chiang Mai, 3. Chon Buri, 4. Samut Prakan, 5. Prachuap Khiri Kan,
6. Samut Sakhon, 7. Pathum Thani, 8. Nakhon Pathom, 9. Khon Kaen
10. Nakhon Ratchasima, 11. Nonthaburi, 12. Songkhla, 13. Tak, 14. Udon Thani,
15. Suphanburi, 16. Sa Kaeo and 17. Rayong

General measurement (announcement on 17 and 18 April 2021)

- Prohibited Activities
 1. lassroom teaching/ lecturing or any activities that involve crowning in all academies
 2. Event gathering/any activity exceeding 50 persons
 3. All type of diving activities
- Type of business closure
 1. Pubs, Bars, Karaoke, entertaining venues
 2. Massage parlours including spas
 3. Refrain to grant license or to host boxing, animal fighting or gambling activities
 4. Theatres, Water parks including swimming pool with equipment or playthings.
 5. Indoor exercise venues (i.e. gyms, fitnesses, badminton courts)
- Intergraded control measures
 1. All F&B sales are allowed up to 11 pm
 2. No drinking of alcoholic drinks in the shops or any type of restaurants
 3. Shopping centres, malls, community malls, are allow to operate up to 9 pm. Except in the part of game arcades, playthings, game shops or amusement park are not allowed to operate.
 4. Convenience stores, supermarkets, night markets street markets can be opened but not later than 11 pm. 24-hours convenience stores are allowed to reopen at 4 am.
 5. Outdoor sport stadiums/venues are allowed to open not later than 9 pm.
- Refrain or avoid traveling
- Social gathering activities
 1. Refrain any social gathering events
- Measures on entering Phuket
 1. Traveller from 17 provinces required to
 - a. Download Morchana application
 - b. Online Registration at www.gophuget.com to inform your place of stay before entry Phuket
 - c. Each traveller is required to do self-monitoring (keep distance of at least 1 meter from other, refrain from public areas or crowed places and refrain from sharing personal belonging items.
 - d. Accommodation business providers require to screen, do temperature check and keep individual record of each guest of location and time of where the guest travel to through all the period of stay and report to EOC (see attached form in page 5)

2. Traveller from 59 provinces
 - a. Download Morchana application
 - b. Online Registration at www.gophuket.com to inform your place of stay before entry Phuket
 - c. Each traveller is required to do self-monitoring (keep distance of at least 1 meter from other, refrain from public areas or crowded places and refrain from sharing personal belonging items).
