

# **Terms and Conditions of the Staking Welcome Rate Marketing Campaign**

**Version 1.1**

**Effective Date: December 24, 2025**

## **1. Organizer**

The Organizer of this Campaign is EMCD Tech Limited , a company incorporated under the laws of the Hong Kong, (hereinafter referred to as the “Organizer”), operating the EMCD platform at <https://emcd.io>.

## **2. Campaign Name and Duration**

**Campaign name:** “Staking Welcome Rate”

**Duration:** Starting December 24, 2025, GMT+0 until January 31, 2026 unless stated otherwise.

## **3. Territory**

The Campaign is valid in all countries except jurisdictions where the use or promotion of cryptocurrency is restricted or prohibited by law or subject to sanctions under international or national regulations.

## **4. Eligibility**

Participation is open to individuals who:

- are at least 18 years old (or legal age in their country);
- have a verified EMCD account
- **Geographic Compliance:** Are **not** residents of the United States, Canada, the United Kingdom, the United Arab Emirates, or the European Union (specifically including Germany, Austria, the Netherlands, and Switzerland).
- **Minimum Participation:** Initiate staking with a minimum of **0.0002 ETH** or **0.001 SOL** starting from **24 December 2025**.

The Organizer reserves the right to disqualify any participant suspected of violating these Terms, providing false information, using multiple accounts, or engaging in fraudulent behavior.

## 5. Participation Requirements

To qualify, participants must complete one or both of the following actions during the Campaign period:

**Explore the Staking Tool:** Users must navigate to the EMCD staking interface and successfully allocate a balance of ETH or SOL into the respective staking pools managed by EMCD.

**Maintain Eligible Balance:** Participants must maintain their staked assets within the pool for the duration of the measurement period to remain eligible for the variable "Welcome Rate" rewards.

## 6. Rewards and Variable APY.

EMCD provides a "Welcome Rate" for specific crypto-assets, which represents the current Annual Percentage Yield (APY) as measured on EMCD's nodes at a specific point in time. You acknowledge that this APY is **variable, not guaranteed, and subject to change** based on market conditions and network protocols. While the Welcome Rate is designed to be competitive, it does not constitute a fixed rate, a promise of future yield, or a guarantee of specific returns. EMCD manages the staking pool; to seek the displayed APY, EMCD may pool, restake, rehypothecate, lend, or utilize derivatives and liquidity pools. Staking involves high-risk crypto-assets, and you could lose part or all of your assets. Rewards might accrue only if network conditions permit, and service availability depends on your jurisdiction. This tool is not a bank deposit, savings account, or investment product, and should not be compared to traditional financial securities.

## 7. Restrictions and Early Termination

The Organizer reserves the right to:

- suspend, amend, or terminate the Campaign at any time without notice;
- adjust Campaign rules, duration, eligibility criteria, or selection mechanism;
- reject or disqualify entries that are incomplete, ineligible, or fraudulent.

## 8. Force Majeure

The Organizer shall not be liable for any failure to fulfill its obligations under this Campaign where such failure results from causes beyond its reasonable control, including but not limited to:

- natural disasters, pandemics;
- power outages or internet disruptions;
- wars, civil unrest, or political instability;
- legal or regulatory changes;
- failure of third-party platforms or services.

## 9. Use of Personal Data

By submitting their email address, participants consent to the Organizer processing their data for:

- administering the Campaign;
- notifying winners and confirming eligibility;
- sending promotional materials, product updates, and personalized offers related to EMCD.

Participants may opt out of marketing communications at any time via the unsubscribe link in emails.

Personal data will be processed in accordance with EMCD's Privacy Policy.

## 10. Liability

Participation is voluntary. The Organizer disclaims all liability for:

- service disruptions, errors, or data loss;
- inability to contact or credit a winner due to incorrect or inaccessible email addresses;
- any taxes, fees, or legal obligations incurred by the participant due to receipt of the prize.

To the fullest extent permitted by law, the Organizer shall not be liable for any indirect, incidental, or consequential damages related to this Campaign.

## 11. Other Terms

- This Campaign is a promotional event and **not a lottery, gambling activity, or public offering.**
- The Organizer is not obliged to enter into any correspondence regarding the outcome.
- The Organizer may publish anonymized winner data (e.g. usernames or initials) via official channels.
- If any provision of these Terms is found to be unenforceable, the remaining terms shall remain in effect.
- These Terms are governed by the laws of the Hong Kong.
- In the event of conflict between translated versions of these Terms, the **English version shall prevail.**
