**School fee structure Holland International School (HIS)
School year 2026 – 2027**

School terms

The school year 2026-2027 consists of three terms:

- Term 1: 17 August 2026 – 18 December 2026
- Term 2: 12 January 2027 – 25 March 2027
- Term 3: 12 April 2027 – 25 June 2027

REGISTRATION FEE

For new students joining the preschool or the primary school

Consists of two components (reference is made to the HIS admission policy):

- S\$ 545 (non-refundable) per student upon application
- S\$ 3,270 (non-refundable) per student upon confirmation of admission

PRIMARY SCHOOL FEES

Dutch Stream Group 1-8 (4 to 12 year old students)

- S\$ 30,516 payable in three instalments per school term:
 - Term 1: S\$ 13,980
 - Term 2: S\$ 8,012
 - Term 3: S\$ 8,524

English Stream Reception-Year 6 (4 to 11 year old students)

- S\$ 30,516 payable in three instalments per school term:
 - Term 1: S\$ 13,980
 - Term 2: S\$ 8,012
 - Term 3: S\$ 8,524

Invoices will be sent by the 1st of June 2026, the 1st of October 2026 and the 1st of February 2027 for the 1st, 2nd and 3rd terms respectively and are payable within 30 days as stated in each invoice.

Start after a school term has commenced (new student)

If a student joins after the commencement date of a term, the following fee structure applies:

- Joining after 25 October 2026: 50% of the term 1 school fee
- Joining after 14 February 2027: 50% of the term 2 school fee
- Joining after 23 May 2027: 50% of the term 3 school fee

Start after a school term has commenced (transfer from preschool)

If a student transfers from preschool to primary school (when turning 4 years old), the following fee structure applies:

- Transfer in Mid-October: 60% term 1 preschool fee + 40% term 1 primary school fee

Preschool hours:

Half day: 8.30 am – 12.30 pm

Full day: 8.30 am – 2.30 pm, except Fridays 8.30 am – 1.30 pm

Invoices will be sent out by the 1st of June 2026, the 1st of October 2026 and the 1st of February 2027 for the 1st, 2nd and 3rd terms respectively and are payable within 30 days as stated in each invoice.

¹ Applicable only to Playgroup (not to Nursery or Transition Group)

² Applicable only to Playgroup and Nursery (not to Transition Group)

Start after a preschool term has commenced:

If a student joins preschool after the commencement date of a term, the following preschool fees (based on 3 or 5 days) applies:

- After 25 October 2026: 50% of term 1 preschool fee
- After 14 February 2027: 50% of term 2 preschool fee
- After 23 May 2027: 50% of term 3 preschool fee

WITHDRAWAL – PRESCHOOL AND PRIMARY SCHOOL

The latest dates for notice of withdrawal are:

- For term 2: 18 September 2026
- For term 3: 15 January 2027
- For term 1³: 25 March 2027

If notice of withdrawal is not given on or before the above-mentioned date, the ensuing (pre-)school term fee will be charged in full. Terms of withdrawal also apply if enrolment is withdrawn before a student joins the (pre-)school. The HIS is not obliged to refund any school fees paid.

WITHDRAWAL DURING TERM – PRESCHOOL AND PRIMARY SCHOOL

Students can be leaving the school during a term as long as notice has been given upfront in accordance with the above-mentioned notice dates. For example: if a student will begin term 2 but will withdraw before the end of the term, HIS must be notified before 18 September 2026 of the date of the last day of (pre-)school; otherwise, the full term 2 fee will be charged.

For withdrawal during a term (only if in accordance with the notice period), the following (pre-)school fee structure applies:

- For term 1, if the last day of (pre-)school is before 25 October 2026: 50% of the applicable term 1 fee is payable;
- For term 2, if the last day of (pre-)school is before 14 February 2027: 50% of applicable term 2 fee is payable;
- For term 3, if the last day of (pre-)school is before 23 May 2027: 50% applicable term 3 fee is payable;
- After these dates, the full applicable term fee is payable.
