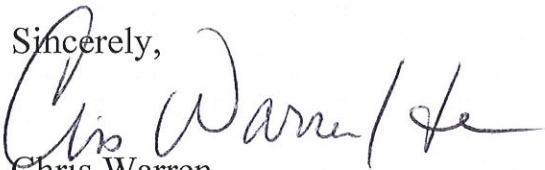
Dear Mr. Wright,
