# **RULE FOR FORMAL ADOPTION**

## **AUGUST 25, 2021 COMMISSION MEETING**

### **Office of the Governor Division of Administration Racing Commission**

Procedure (LAC 35:XIII.11609)

In accordance with the provisions of the Administrative Procedure Act, R.S. 49:950 et seq., and through the authority granted in R.S. 4:148, notice is hereby given that the Racing Commission formally amends LAC 35:XIII.11609. The Rule better clarifies for the public what happens to the portion of a Pick N wager in the instance that there is a change of racing surface due to conditions of the course. This Rule is hereby adopted on the day of promulgation.

### **Title 35 HORSE RACING Part XIII. Wagering**

#### **Chapter 116. Pick N §11609. Procedure**

A. – F. ...

G. If the condition of the course warrants a change of racing surface in any of the legs of the Pick N races, and such change was not known to the public prior to the closing of wagering for the Pick N pool, the stewards shall declare the changed leg(s) an all win for Pick N wagering purposes only.
