## TERMS OF USE

*Cors'Express website*

These Terms of Use (the "Terms") govern access to and use of the website [www.corsexpress.com](http://www.corsexpress.com) (the "Website") and the associated digital services provided by CORS'EXPRESS S.A.S.

### **Article 1 — Purpose**

### **Article 2 — Access to the Website**

The user is solely responsible for the confidentiality of the login credentials. Any use of the account is deemed to have been made by the user.

All elements making up the Website (text, images, videos, logos, trademarks, databases, etc.) are protected by the intellectual property laws in force. Any reproduction, representation, modification or exploitation, in whole or in part, without the express authorisation of Cors'Express is strictly prohibited.

Personal data collected via the Website is processed in accordance with Regulation (EU) 2016/679 ("GDPR") and applicable French law. The processing terms are set out in detail in the Privacy Policy available on the Website.
