# COOKIE POLICY

*Cors'Express website*

This Cookie Policy describes the use of cookies and similar tracking technologies on the website [www.corsexpress.com](http://www.corsexpress.com) (the "Website") published by CORS'EXPRESS S.A.S., in accordance with the French Data Protection Act and the recommendations of the CNIL.

## 1. What is a cookie?

A cookie is a small text file placed on the user's device (computer, tablet, smartphone) when visiting a website. It allows the user's device to be recognised, preferences to be stored or information on browsing to be collected.

## 2. Categories of cookies used

Cors'Express uses the following categories of cookies:

### 2.1 Strictly necessary cookies

These cookies are essential for the operation of the Website (session management, booking basket, security). They do not require consent.

### 2.2 Audience measurement cookies

These cookies make it possible to produce anonymous statistics on the use of the Website (pages visited, duration of visits, user journey) in order to improve its ergonomics and content. They are placed subject to the user's consent.

### 2.3 Functional cookies

These cookies allow the user's preferences (language, currency, favourite ports) to be remembered in order to personalise the browsing experience. They are placed subject to consent.

### 2.4 Advertising and partner cookies

These cookies may be placed by partners of Cors'Express (distributors, booking platforms, agencies) or by advertising service providers. They are placed only after obtaining the explicit and prior consent of the user.

## 3. Consent management

On the first visit to the Website, a consent banner informs the user of the use of cookies. In accordance with the recommendations of the CNIL, this banner allows you to accept or refuse non-strictly-necessary cookies with the same ease, as well as to configure your choice by category of cookies. Only strictly necessary cookies are exempt from consent.

You may at any time amend or withdraw your consent, with the same ease as that with which it was given, via the "Manage cookies" link available at the bottom of the Website. Withdrawing consent does not affect the lawfulness of the processing carried out prior to withdrawal.

## 4. Retention period

The retention period of cookies does not exceed 13 months from their placement. At the end of this period, the user's consent is requested again.

## 5. Disabling cookies via the browser

You may configure your browser to accept, refuse or delete cookies. The procedures vary according to the browser used:

- Google Chrome: Settings > Privacy and security > Cookies
- Mozilla Firefox: Options > Privacy & Security
- Safari: Preferences > Privacy
- Microsoft Edge: Settings > Cookies and site permissions

Refusing certain cookies may limit or prevent access to certain features of the Website.
