3. Cancellation Policy

- Cancellations made **60 days or more** before the event will receive a full refund (less a \$35 processing fee or 10% of the Rental Fee (the greater of the two amounts)).
- Cancellations made **within 30 days** of the event date will forfeit 50% of the Rental Fee.
- Cancellations made **within 14 days** of the event date will forfeit the entire Rental Fee.
- Owner reserves the right to cancel the event for any safety or legal reason with a full refund to Renter.

4. Use of Premises

Renter agrees to:

- Use the space only for the event described above.
- Comply with all local laws, noise ordinances, and venue rules.
- Not exceed maximum occupancy limits.
- Obtain all necessary permits or licenses (e.g., liquor license, entertainment permit, etc.).
- Review and comply with the Fire Safety Plan posted at the venue
- Not have music that is so loud that it causes a disturbance to other tenants in the building, and agrees to reduce noise to modest level by 11pm.

5. Damage and Liability

- Renter is responsible for all damages to the property, fixtures, games, or equipment caused by the Renter, their guests, or vendors. Renter authorizes Owner to process their credit card on file for the amount of the damages caused. Owner agrees to provide an itemized statement to Renter for any additional charges.
- The Owner is not liable for injury, loss, or damage to persons or personal property during the event.
- Renter is encouraged to obtain event insurance.

6. Cleaning

Renter shall ensure:

- All personal items, trash, and decorations are removed by the end of the rental period.
- Floors, counters, and bathrooms are left in clean condition.
- Renter agrees to pay additional cleaning fees IF the premises require extensive cleaning.

7. Alcohol, Food, and Vendors

- Beer and Wine is permitted only after Renter obtains a Temporary Beer/Wine permit from the state of IN.

- Liquor is only permitted to be served by a licensed and insured vendor (Mobile Alcohol Caterer).
- Food and beverage vendors must comply with health and safety standards.
- Renter is responsible to ensure that their party does not get out of control.
- All third-party vendors must carry liability insurance and provide proof upon request.

8. Indemnification

Renter agrees to indemnify and hold harmless the Owner, its employees, and agents from any claims, damages, or expenses arising from the Renter's use of the premises.

9. Governing Law

This Agreement shall be governed by the laws of the State of Indiana.

10. Entire Agreement

This document constitutes the entire agreement between the parties. No other terms or representations shall have any effect unless in writing and signed by both parties.
