For development and testing environments, Nextpoint restricts access to client data to authorized personnel only through role-based access controls and leverages security measures to protect confidential, personal, and other sensitive information as needed. Nextpoint employs an enterprise Secure Software Development Life Cycle (SDLC) as part of its ongoing commitment to building and maintaining secure applications.

Nextpoint's Site Reliability Engineering Team assesses security risks on an ongoing basis, monitors access logs, addresses known incidents, and applies security patches. Nextpoint conducts a comprehensive, annual IT risk assessment to ensure and maintain SOC II Type 2 Compliance.

AI security

Unlike general-purpose AI tools that may expose confidential data, Nextpoint's AI capabilities operate entirely within our secure cloud environment. All AI processing maintains the same enterprise-grade security protections as the rest of the Nextpoint software.

Our AI features are built on Amazon Bedrock, AWS's fully managed service for foundation models. [Key protections](#) include:

- **No Model Training:** AWS Bedrock does not use customer data to train or improve foundation models
- **No Data Storage:** Bedrock doesn't store or log prompts or completions
- **No Third-Party Sharing:** Input and output data are never shared with model providers
- **Encryption:** All AI interactions are encrypted in transit and at rest

That vision extends directly to how we think about AI: legal teams are exploring it faster than ever and asking harder questions about it. This document outlines the principles, architecture, and safeguards behind every AI feature at Nextpoint.

Our AI Principles

Purpose-Built for Legal Work

Tools designed with your day-to-day in mind.

Every Nextpoint AI feature is designed around real legal workflows, with input from legal experts on what attorneys actually need. AI Transcript Summaries, for example, offers Narrative, Chronological, and Table of Contents formats — each serving a unique purpose, but all reducing time spent on transcript review.

Architectural Security

Your privileged client data stays inside the Nextpoint environment.

Nextpoint's AI features run entirely on AWS, within Nextpoint's own secured cloud environment — the same environment protected by AES-256 encryption, SOC 2 Type II controls, and role-based access.

No Training on Your Data

Your case data is never used to train external models.

Your data is never used to train or improve any foundation model. AWS does not use customer data to train or improve its foundation models and does not share input or output data with model providers. Your confidential case information is never repurposed to make other AI smarter.

Human in the Loop, Always

AI accelerates your review — it doesn't replace judgment.

Nextpoint's AI features are designed to help attorneys decide where to focus, not to make decisions for them. Summaries, results, and generated content are starting points for review. Human judgment remains essential to every case decision.

Our Approach to AI

Legal work requires judgment, expertise, and insight that no tool can replicate. AI should surface key information and accelerate large-scale data import and review, so your team can focus on strategy and winning the case. Our philosophy is that powerful, secure technology shouldn't be reserved for the firms with the biggest cases or biggest budgets. We build tools that make every attorney faster, sharper, and more effective.

How We Build AI Responsibly

Nextpoint's AI features run entirely on AWS, within Nextpoint's own secured environment. Depending on the feature, processing uses a combination of AI models that Nextpoint self-hosts inside its private cloud (VPC) and/or uses Amazon Bedrock and Amazon SageMaker. Case content is never routed externally to a public or consumer-facing AI tool.

The Architecture Behind Nextpoint AI

- **No model training:** Your data is never used to train or improve any foundation model. Amazon Bedrock does not use customer inputs or outputs to train its models.
- **No provider retention or sharing:** Prompts and outputs sent to the managed foundation-model service are neither retained by nor shared with any external model provider.
- **Processing stays in your environment:** Semantic search and ranking run on models Nextpoint hosts inside its own VPC. Generative steps (such as transcript summaries and match explanations) run on Bedrock within Nextpoint's AWS environment. In all cases, your case content stays within Nextpoint's AWS account and is never exposed to an external AI company.
- **Encryption everywhere:** All AI interactions are encrypted in transit and at rest.
- **Consistent controls:** The same security program that governs the rest of the platform — role-based access, audit trails, and multi-factor authentication — also applies to AI-powered features.

AI in Practice: AI Transcript Summaries

[AI Transcript Summaries](#) is a practical example of these principles at work. Instead of hours of manual review, attorneys can generate Narrative, Chronological, and Table of Contents summaries of a deposition in minutes — directly inside the same workspace where their transcripts, exhibits, and case materials already live.

Attorneys get faster context on testimony without introducing a new point of exposure for confidential case data.



AI in Practice: AI Search *Coming soon!*

AI Search pairs keyword precision with natural language understanding. Instead of relying on Boolean queries alone, legal teams can describe what they need in plain language and surface semantically relevant documents. Your documents remain within Nextpoint's secure AWS environment at all times and are never copied to, stored in, or made accessible to any external or third-party system.

Every part of AI Search runs inside that same secure environment. Keyword matching, semantic matching, and ranking are all handled by models Nextpoint hosts on its own infrastructure, so your document text never leaves your secured storage or reaches an outside AI company. When AI Search explains why a document matched, that explanation is generated by an AI service running on AWS within Nextpoint's environment, under contractual terms that prohibit training on your data and retention of it beyond processing. Your document text stays inside your secure environment for this step, too. This feature can be enabled or disabled per case.

Nextpoint never uses your documents to train any AI model and never shares your data with third parties. AI Search does not change who can see your data: access stays restricted to you and your authorized team, under the same controls that govern every document in your database. It makes finding and reviewing documents faster without expanding data exposure, changing data ownership, or altering access permissions.

Q: *How accurate are AI-generated results?*

A: AI features are built to accelerate attorney review, not replace it. We validate features through extensive testing before release. Generated summaries, results, and insights are intended as starting points, with attorney judgment guiding case strategy. We encourage you to always trust, but verify results.

Q: *Is our data shared with outside AI providers?*

A: No. Inputs and outputs are never shared with or retained by any outside model provider.

Q: *How is this different from using a tool like ChatGPT and Claude directly on case files?*

A: General-purpose consumer AI tools are not purpose-built for confidential legal data, and some may use inputs to improve their models depending on the plan or subscription. Nextpoint's AI runs inside an isolated environment with no model training, no data retention by the model provider, and no third-party sharing. Our philosophy is that powerful, secure technology shouldn't be reserved for the firms with the biggest cases or the biggest budgets.

Q: *What compliance framework covers Nextpoint's AI features?*

A: AI features are covered by the same security program as the rest of the platform, including SOC 2 Type II compliance and Nextpoint's annual IT risk assessment.
