# The Future of Healthcare: Automating Radiology Prior Authorizations at Bellin and Gundersen Health System with Humata's Automation and AI

How Bellin and Gundersen's exception-based workflow is redefining Prior Authorization for both staff and patients.

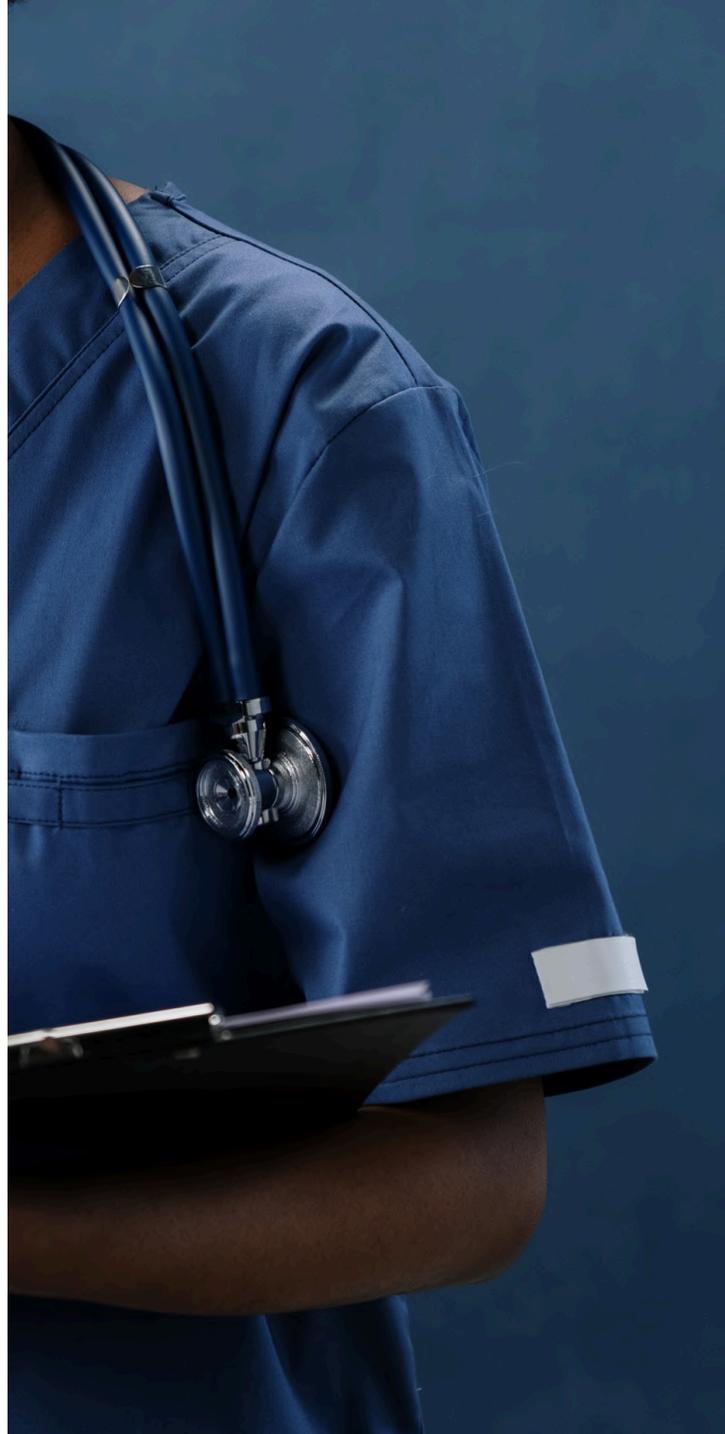
## THE CHALLENGE

The system's Gundersen Region faced a significant challenge in managing prior authorizations, particularly for their imaging services, which represented one of the highest volumes of service lines requiring prior authorization. The process was entirely manual, with limited automation tools in place to streamline the workflow. This lack of automation meant that staff members had to individually review each order to determine the services being scheduled, then navigate to various payer portals to confirm if the scheduled visit required an authorization. This initial step was cumbersome and time-consuming, diverting valuable resources away from high/complex case review.

The submission process for prior authorizations was identified as the most time-consuming component. Staff members had to transcribe a vast amount of information into the payer portals after gathering the necessary clinical documentation. This manual transcription not only increased the risk of errors but also significantly slowed down the process, leading to delays in patient care.

Moreover, after an authorization was submitted, the staff had to manually check the status of each authorization. This inefficient process did not allow the team to prioritize effectively; they could not focus on the cases that truly required action. The manual checking of authorization status often resulted in unnecessary follow-ups and wasted effort, further complicating the workflow and increasing the administrative burden on the staff.

The need for a solution was clear. Bellin and Gundersen required a more efficient, streamlined process that could reduce the manual workload on staff, minimize errors, and expedite the prior authorization process to ensure timely patient care.

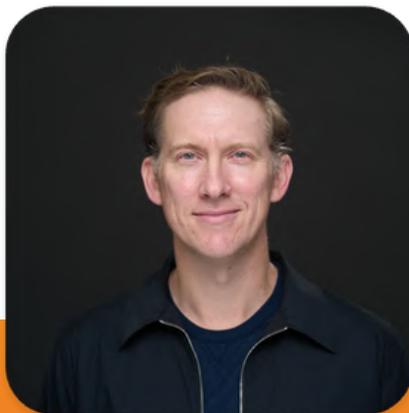
