### Setup Documents

- Trade License
- Share Certificate
- Certificate of Incorporation
- Memorandum & Articles of Association

### Personal Documents

- Passport copy of all shareholders
- Emirates ID of all shareholders
- Brief company profile
- CV of all shareholders
- Proof of contract with clients or suppliers
- 3 months' bank statement
- Proof of utility bill payment

## Documents you will receive when you start your business

- Business License
- Certificate of Formation
- Share Register
- Lease Agreement
- Memorandum of Association (MOA)

## Terms & Conditions

- A certificate of Incumbency should be issued within the last three months.
- All company documents should be notarized by issuing authority.
- Original documents should be submitted within two months of issuing the license; failing which, the business license from Meydan Free Zone will be revoked.
- Only copies of corporate documents will be required from companies registered with authorities with online registers, wherein details can be obtained electronically.
- It is suggested to mention unpaid capital of AED 100,000 on the company MOU
- General T&C Policies apply.
