### 4) Your innovation: What is the core innovation for which you are requesting DIV Fund support? How does your innovation compare to existing alternatives?

Please describe:

(i) *What your innovation is and how exactly it works*: Describe what your specific product, service, policy, or delivery/financing approach is. Walk us through a typical use case: who is the user, and what specifically happens when they engage with your innovation?;

(ii) *How it compares to existing alternatives*: What are the current solutions, and how and why does your innovation represent a clear improvement over these alternatives?

### 5) Theory of change: What key development outcomes do you expect your innovation to improve, and how?

Please describe the:

(i) Key measurable outcomes your innovation aims to improve (i.e., increased consumption, lives saved, improved test scores, etc.), and how these directly address the specific development challenge you are focused on; and your

(ii) "Theory of change": Walk us through the specific causal chain from your innovation to impact: what happens first, what changes as a result, and how does that ultimately lead to

your target outcomes? Be specific about the mechanism and existing evidence supporting your assumptions, i.e., what does your innovation change about behavior, access, knowledge, or resources, and why would that lead to the outcome you expect?

**6) Use of funding: What specific activities will the DIV Fund grant support?**

<sup>4</sup> Causal evidence means evidence that shows your solution directly caused the change in outcomes, not just that outcomes improved while your solution was in place. Strong causal evidence would involve comparing people who received your solution to a credible counterfactual (i.e., a similar group who did not receive the solution), often through a randomized controlled trial or well-designed quasi-experimental evaluation, in order to see whether outcomes are meaningfully different. (2) Projected unit cost at scale: Your projected cost per person at larger scale, including the scale at which this cost estimate applies. Highlight major cost drivers and whether/how you expect these to change as you scale.

**10) Scale: Approximately how many people has your innovation directly reached to date? How many people do you expect your innovation to reach during the grant period, how many people will be reached at scale, and how will this be sustained?**

Provide your best estimate of:

(1) Current scale: The number of people directly reached to date (e.g., people who have received, used, or purchased the innovation). Clearly describe how people currently access the innovation (e.g., through direct sales, government program, delivery partner, digital platform), specifying who bears the costs: whether users pay full cost, receive subsidies, or access it for free.

(2) Anticipated scale: The number of people you anticipate your innovation directly reaching during the proposed grant period, and the number of people you anticipate it will reach at scale. Clearly state the main assumptions and data behind your projections. Clearly describe how you expect people will access the innovation, who will ultimately pay for it (e.g., governments, donors, customers), and any evidence supporting their willingness and ability to cover the cost. What existing commitments, demand signals, policy alignment, or market traction suggests the innovation could realistically scale in this manner? Please be sure your answer aligns with your expectation for your innovation's expected long-term pathway to scale.

**11) Evidence and learning: What are the key questions you will answer during the DIV Fund grant period?**
