FACTS – What does Four Points Capital Partners do with your personal information?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include the following:

- Social Security number and income
- Date of birth
- Employment information
- Account balances, assets, and investment experience
- Risk tolerance and transaction history

How?

All financial companies need to share customers' personal information to conduct everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons FPCP chooses to share; and whether you can limit this sharing.

How does FPCP protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We employ physical, electronic, and procedural safeguards for the protection of the personal information we collect about you.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial or nonfinancial companies.
Non-Affiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies, including <ul style="list-style-type: none"> ▪ Investment advisor firms, mutual fund companies, and insurance companies
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ▪ FPCP does not jointly market with non-affiliates.
Other Important Information	<ul style="list-style-type: none"> ▪ For California residents, we will limit the sharing of your nonpublic personal information to the extent required by California law. ▪ For Vermont residents, we will limit the sharing of your nonpublic personal information to the extent required by Vermont law. ▪ For Nevada residents, which apply to accounts with Nevada mailing addresses, you may elect to be placed on our internal "do not call" list.
