NSA Storage Strengthens Vendor Compliance and Reduces Operational Risk with NetVendor

NSA Storage transformed a manual, high-risk compliance process into a streamlined, audit-ready operation across more than 1,100 locations using NetVendor's automated onboarding, compliance management, and trusted vendor sourcing tools.

OVERVIEW

NSA Storage is one of the largest self-storage operators in the United States. With more than 1,100 facilities nationwide, the organization relies on an **extensive vendor network** to support daily operations, maintenance, and on-site service needs across a geographically dispersed portfolio.



As NSA's portfolio expanded, tracking COIs, W-9s, and renewals through spreadsheets and emails became unmanageable.



CHALLENGE

During a period of rapid expansion, NSA's manual compliance workflow could no longer keep pace. Teams were managing COIs, W-9s, and renewals through spreadsheets, emails, and scattered documentation, a process that was difficult even with a full-time compliance role in place.

Documentation quickly became outdated, renewals were easily missed, and visibility across thousands of vendors was limited. When an audit revealed several compliance gaps, it confirmed what the team already knew: their process was risky, inefficient, and not scalable for a portfolio of this size.

THE SOLUTION
